May kindly see the letter dated 4.5.2016 at flag 'A' of Smt. Seema Singh, Civil Judge(Jr.Div.), Kanpur-Nagar by which she has submitted the property statements for the financial years 2009-10, 2010-11, 2011-12 and 2012-13.

Earlier officer has submitted her property statement of at the time of entering into Judicial Service vide her letter dated 15.4.13(flag 'B') but she has not submitted her immovable property statement of at the time of entering into Judicial and property statements for the financial years 2009-10 and 2010-11, hence a Court's letter dated 18.5.2013 (flag 'C') has been sent to the officer in this regard. In reply of aforesaid Court's letter, officer through her letter dated 24.11.2014(flag 'D') has submitted that ~~She has~~ no immovable property at the time of entering into service. Then Court's letters dated 20.12.2014 and 30.9.15 (flag 'E' and 'F') has been sent to the officer to send her property statements for the financial years 2009-10, 2010-11, 2011-12 and 201-13 after mentioning the details of deductions of her salary. In reply of aforesaid Court's letter, Officer has submitted her property statements for the financial years 2009-10, 2010-11, 2011-12 and 201-13 vide her letter dated 19.1.2016 ('G') but all her aforesaid movable property statements were not on proper proforma. Thereafter a Court's letter dated 16.2.2016(flag 'H') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted her property statements for the financial years 2009-10, 2010-11, 2011-12 and 201-13 in proper proforma vide her letter dated 4.5.16(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property of at the time of entering into U.P.Judicial Service and for the financial years property statements for the financial years 2009-10, 2010-11, 2011-12 and 201-13 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

at the time of entering into U.P.Judicial Service, Officer has following movable property:-

1. Furniture
2. Gold and Diamond Ornaments - 525 gms.
3. T.V.
4. Fridge
5. A.C.

In the statement of movable and immovable property for the financial year 2009-10, Smt. Singh gross income from salary is Rs.2,40,908/- and from this amount Rs.2,270/- deducted against GIS and Income Tax. As such, total deductions/Saving/investment is Rs.2270/- . Thus a sum of Rs.2,38,638/- was therefore available with her to meet out her household expenditure of her family consisting of only one member in financial years 2009-10.


In the statement of movable and immovable property for the financial year 2010-11, Smt. Singh gross income from salary is Rs.4,37,392/- from this amount Rs.1440/- deducted against GIS, Rs.24,280/- against Income Tax. The balance of her Saving bank account(s) enhanced for Rs.1021/- this financial year. As such, total deductions/Saving/investment is Rs.26,741/-. Thus a sum of Rs.4,10,651/- was therefore available with her to meet out her household expenditure of her family consisting of two members in financial years 2010-11

In the statement of movable and immovable property for the financial year 2011-12, Smt. Singh gross income from salary is Rs.6,73,688/- from this amount Rs.2840/- deducted against GIS, Rs.43,000/- against Income Tax, Rs.81,000/- against PPF, Rs.20,000/- against

The explanation submitted by the officer is plausible.

However, the officer be cautious in future while submitting the property statements well within time in accordance with the circulars issued by the High Court in this regard.



IDFC fund, Rs.19,795/- against LIC. The balance of her Saving bank account(s) enhanced for Rs.1037/- this financial year. As such, total deductions/Saving/investment is Rs.1,67,672/-. Thus a sum of Rs.5,06,016/- was therefore available with her to meet out her household expenditure of her family consisting of two members in financial years 2011-12.

In the statement of movable and immovable property for the financial year 2012-13, Smt. Singh gross income from salary is Rs.5,46,982/- from this amount Rs.84,861/- deducted against GIS and Income Tax and Rs.40,000/- against PPF. As such, total deductions/Saving/investment is Rs.1,24,861/-. Thus a sum of Rs.4,22,121/- was therefore available with her to meet out her household expenditure of her family consisting of three members in financial years 2012-13.

It is pertinent to mention here that the husband of the officer Sri Sandeep Chaudhary is also Civil Judge(Jr.Div.).

The officer has submitted his property statement of at the time of entering into Judicial Service vide her letter dated 15.4.13 (flag'B') which was due to be submitted at the time of her joining the U.P. Judicial Service. The officer has submitted his property statements for the financial years 2009-10 and 2010-11 firstly vide his letter dated 19.1.16(flag 'G') which was due to be submitted in the financial year 2011-12 i.e. on or before 31.3.12 and officer has submitted her property statements for the financial years 2011-12 and 2012-13 firstly vide his letter dated 19.1.16(flag 'G') which was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14. As such there is delay in submitting the aforesaid property statements of the officer due to certain family commitments and work load. She could not sent the statements in time and the directions issued by the Hon'ble Court was also slipped from her mind as she has two young kids and she has to look after them also alongwith her Court work. Therefore, she tender her unconditional apology for the mistake committed by her and also assure this mistake will not be repeated in future.
