(65) May kindly see the application letter dated 17-11-2009 of Seema Singh, Addl Civil Judge (Junior Division), Hathras duly forwarded by the Director, Institute of Judicial Training & Research, U.P Lucknow regarding request for certification of character of Application form of Delhi judicial service examination 2010 to the proforma provided herewith placed below, at page 'A' and 'B'.

Through her letter dated 17-11-09, Seema Singh has stated that she wish to appear in Delhi judicial service examination 2010. The application form of the said examination requires certification by the Head of the department/ office for onward transmission to Honble Delhi High Court. She has further stated that she has sent an advance copy of the said form to Delhi High Court in anticipation of getting permission as well as required certification from the Honble Court (Head of department).


Now Seema Singh has requested the court to grant him permission and certification required and for that purpose she is sending second copy (copy) of the original duly filled form for granting of the certification as prescribed in the application form and its submission to the Delhi High Court.

In this connection it may be submitted that in respect of forwarding of application of UP Government employee to the other State, the provision contained in para 11 of G.O No 1612/1968 - Kasmik-2 dated 19-6-2009 which was being

reproduced here-in as under in Verbal

It may further submitted that Seema
Sinha has directly submitted her application
form for Delhi judicial service examination
2010 to the Delhi High Court and she has
submitted second copy (Xerox copy) of original
application form of Delhi judicial service
examination 2010 to this court for grant of permission as well
and certification required in the form of stamping
provided in therein and towards the application
form (second copy) to Delhi High Court.



In this connection it may be submitted that in another case of KM Bushra Adil Rizvi Addl Civil Judge (Junior Division), Azamgarh had sent original application form appearing in Delhi Judicial Service examination 2010 to this Court with the request to forward her said application form to Delhi High Court after signing the necessary certificate in the capacity of Head of Department mentioned on the last page of form. Hon'ble Chief Justice has passed an order dated 24-11-2009 (tagged ^{xx}) to forward her application to Delhi High Court after making signature on the ~~said~~ ~~application~~ ~~form~~ ~~require~~ certificate given on the last page of the said form.

On the instant case, the original application form has already been furnished by Seema Singh, Addl Civil Judge (Junior Division) Hathras to Delhi High Court directly in anticipation of court's order she may do so under the provision contained in G.O No 16/2/1968. Karmik-2 dated 19.6.1979. referred to above. But in the opinion of the office necessary certificate can not be given to her on the photocopy of the application form. On this of that a certificate may be granted to Seema Singh, Addl Civil Judge (Junior Division) Hathras that Court has no objection if she appear in the examination of Delhi judicial service 2010.
