May kindly see the letter of Smt. Ritu Nagar, the then Judicial Magistrate, Muzaffarnagar, now posted as Additional Civil Judge (J.D.), ^{Muzaffarnagar} ~~Sitapur~~ forwarded by District Judge, Muzaffarnagar vide his letter No.1960/XV-08/2015, dated 23.09.2015 regarding Medical reimbursement claim amounting to Rs. 33,610.00 of Smt. Ritu Nagar incurred in the treatment of her own, for the period of treatment from 04.05.2014 to 08.05.2014 at Lok Priya hospital, Meerut, placed below at **Flag 'A'**.

The instant medical claim is time barred and it was sent by the District Judge, Sitapur to the Government without forwarding it through proper channel i.e. High Court, Allahabad for obtaining relaxation for delay in submission of claim. Thus, through ^{letter} ~~G.O.~~ no. 646/do-4-2015-53(1)/2015 dated 01.05.2015, placed below at **Flag 'B'**, the Government has asked from District Judge, Sitapur to resend the claim to the Government through the High Court, Allahabad. Thus, District Judge, Sitapur forwarded the claim along with the aforesaid G.O. to the District Judge, Muzaffarnagar for necessary action. Now, the District Judge, Muzaffarnagar has requested Sr. Registrar, High Court, Allahabad for obtaining necessary orders from the Government regarding condonation of delay in submission of the aforesaid medical reimbursement claim as per the provisions contained in rule 23 of "The Uttar Pradesh Government Servant (Medical Attendance) Rules, 2011".

In the facts and circumstances mentioned above, may if deemed fit and proper, the file may kindly be laid before the Sr. Registrar (Judicial) (Budget), for her kind perusal and order to the effect that the aforesaid medical reimbursement claim along with all original bill/vouchers and other relevant papers as well as aforesaid relevant information may be sent to the Under Secretary, Appointment Section-4, Government of Uttar Pradesh recommending the proposal to kindly obtain necessary orders from the Government regarding condonation of delay in submission of the aforesaid medical reimbursement claim of Smt. Ritu Nagar, as per the reason and circumstances explained by her through her letter dated 07.02.2015, placed below at **Flag 'C'** ?
