May kindly see the G.O. No. 1755/ do- 4-2015-53(1)/2015, dated 1st January, 2016 (at **Flag 'A'**) through which the Government has condoned the delay in submission of the medical reimbursement claim of Smt. Ritu Nagar, the then Additional Civil Judge (J.D.), Sitapur now posted as Judicial Magistrate, Muzaffarnagar, amounting to Rs. 33,610.00 incurred in the treatment of her own, for the period of treatment from 04.05.2014 to 08.05.2014 at Lok Priya hospital, Meerut, within the prescribed time limit, before the sanctioning authority as per rule.

Earlier, the District Judge, Muzaffarnagar vide his letter No.1960/XV-08/2015, dated 23.09.2015 had requested for obtaining necessary orders from the Government regarding condonation of delay in submission of the aforesaid medical reimbursement claim of Smt. Ritu Nagar.

In this connection, it may be submitted that under the provisions contained in rule 20 of "The Uttar Pradesh Government Servant (Medical Attendance) (First Amendment) Rules, 2014" published vide notification no. no.474/V-6-14-1082-87, dated 04.03.2014, the sanctioning authority for Government servant for working/ retired Govt. servant, placed below:-

Amount of claim	Sanctioning authority
Upto Rs.2,00,000.00	Head of office
Above Rs.2,00,000.00 upto Rs.5,00,000.00	Head of Department
Above Rs.5,00,000.00 upto Rs.10,00,000.00	Administrative Department in the Government
Above Rs.10,00,000/-	After recommendation from Medical and Health Department and prior approval of the Finance Department, Administrative Department in the Government.

Thus, it may be submitted that under the above provisions, reimbursement of the aforesaid medical claim amounting to Rs. 33,610.00 is required be sanctioned by the Head of Office i.e. the District Judge, Muzaffarnagar.

In the facts and circumstances mentioned above, if deemed fit and proper, the file may kindly be laid before the Senior Registrar (Judicial) (Budget), for her kind perusal and orders to the effect that the above mentioned medical reimbursement claim amounting to Rs. 33,610.00 of Smt. Ritu Nagar incurred in the treatment of her own, for the period of treatment from 04.05.2014 to 08.05.2014 at Lok Priya hospital, Meerut along-with copy of G.O. No. 1755/ do- 4-2015-53(1)/2015, dated 1st January, 2016 may be returned to District Judge, Muzaffarnagar requesting him to sanction the aforesaid medical reimbursement claim after completion of all formalities in accordance with "The Uttar Pradesh Government Servant (Medical Attendance) Rules, 2011" read with "The Uttar Pradesh Government Servant (Medical Attendance) (First Amendment) Rules, 2014".
