May kindly see letter dated 15.03.19(at flag 'A') of Smt. Ritu Nagar, Additional Civil Judge(Senior Division)/ACJM, Aligarh regarding inclusion of LL.M qualification in her service records and ensuant grant of three advance increments.

Vide aforesaid letter, Smt. Ritu Nagar has informed that she entered into U.P.Judicial Services on 14.05.2009 as Additional Civil Judge(JD), Shahjahanpur. She has further stated that she completed LL.M course in year 2008 from Chaudhary Charan Singh University, Meerut and has thus requested for inclusion of said qualification. In support of same, she has submitted attested copies of degree and mark-sheets of LL.M.

In this context it is submitted that Smt. Ritu Nagar joined U.P.Nyayik Sewa on 14.05.2009. As apparent from submitted copies of mark-sheets and degree(at flags 'M1', 'M2', 'M3', 'M4' & 'D'), Smt. Ritu Nagar had completed LL.M course in year 2008 from Chaudhary Charan Singh University, Meerut i.e prior to entering into U.P.J.S. However, she did not mention detail about course completion in her application form of U.P.Nyayik Sewa as at that time she was pursuing said course, therefore her said qualification is now ought to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P thus qualification of LL.M. may be included in the service records of Smt. Ritu Nagar with the permission of Government of U.P., Lucknow. Besides, it is submitted that benefits of three advance increments can be granted only after inclusion of qualification of LL.M in service records of concerned officer. Therefore, it seems proper that aforesaid application dated 15.03.19 of Smt. Ritu Nagar, Additional Civil Judge(Senior Division)/ACJM, Aligarh may be sent to the Government of U.P. for obtaining necessary orders, so that same may be subsequently placed before appropriate authorities for grant of three advance increments.

In the view of above submissions, if approved by Hon'ble Mr. Justice B. Amit Sthalekar, Administrative Judge, Aligarh, copy of aforesaid letter dated 15.03.19(flagged as 'A') along with attested copies of marksheet & degree of LL.M(flagged as 'M1', 'M2', 'M3', 'M4' & 'D') as well as attested copy of form of U.P.Nyayik Sewa of Smt. Ritu Nagar, Additional Civil Judge(Senior Division)/ ACJM, Aligarh may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
