May kindly see the letter 17.7.14, placed below at flag 'A' received from Sri Vishnu Pratap Singh, Judicial Magistrate, Varanasi regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering into Judicial Service and for the financial years 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 in prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

Earlier Sri Singh has submitted his property statement for the years 2010-2012 vide his letter dated 7.1.13(flag 'B') but he has not submitted his property statement for at the time of entering into Judicial Service and the said statement was not according to the Court's Circular letter dated 13.5.04 hence a Court letter dated 8.2.13(flag 'C') was sent to the officer in this regard. In reply officer has submitted photocopy of property statement of at the time of entering into Judicial Service in which he has mentioned his gross salary and deductions etc. that was not correct and also sent the property statement for the financial years 2009-10 and 2010-11 vide his letter dated 4.3.13(flag 'D'). Then a Court's letter dated 10.4.13(flag 'E') was sent to the officer to submit his revised statement of movable and immovable property on proper proforma. Again a Court's letter dated 3.7.14(flag 'G') was sent to the officer to send his property statement of at the time of entering into Judicial service, property statement for the financial years 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 separately in proper proforma after mentioning his details of deductions of his salary.

In reply officer has submitted his revised property statement of at the time of entering into Judicial Service and for the financial years 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 vide his letter dated 17.7.14(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for at the time of entering into Judicial Service and for the financial years 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings/investment and expenditure made by him are as under, prepared in chart.
