May kindly see the letter dated 11.02.2014 (at Flag 'A') of Sri Kailash Kumar, Civil Judge (Jr. Div.), Kairana, Muzaffarnagar duly forwarded by District & Sessions Judge, Muzaffarnagar regarding grant of personal pay under voluntary family planning programme, in terms of G.O. Pa. Ka. 4601/16-11-79-9/155/79, dated 23.02.1980.

According to papers received from Sri Kailash Kumar through letter dated 10.12.2013 & 11.02.2014 and papers available on his instant personal/ Misc. file details of the claim are as under:

1. His date of birth is 12.09.1971.
2. His present age is more than 42 years 4 months as per his declaration but presently his age is 42 years 5 months 10 days.
3. He joined the service on 29.05.2009.
4. He has only one child vide declaration at Flag 'B'.
5. He has not got the personal Pay under voluntary family planning programme vide declaration at Flag 'C'.
6. The date of birth of his only child is 27.12.2001 vide birth certificate issued by Municipal Corporation, Government of National Capital Territory of Delhi for birth proof and attested copy of certificate is at Flag 'D'.
7. His wife is alive and not getting Personal Pay under Voluntary Family Planning Programme vide declaration at Flag 'B'.
8. Neither any departmental enquiry is pending against Sri Kailash Kumar, Civil Judge (Jr. Div.); Kairana, Muzaffarnagar nor he has been punished by stoppage of increment and he has not been suspended in connection with such enquiry as reported by Section Officer (Confidential-A) section at Flag 'E'.

In terms of G.O. Pa.Ka. 1683/16-11-80-9/155/79 dated 26.05.1980 and G.O. Pa.Ka. 2667/16-11-80-9/155/79 dated 11.06.1980 required declaration have been furnished by Sri Kailash Kumar and same are at Flags 'B' & 'C'.

In this connection, it is submitted that Sri Kailash Kumar, Civil Judge (Jr. Div.), Kairana, Muzaffarnagar has fulfilled all the conditions as laid down in the aforesaid G.O.s for sanction of personal pay under voluntary family planning

programme. Therefore he is entitled to get the benefit of personal pay under voluntary family planning programme equal to one increment or as fixed vide G.O. no. 650/II-4-2013-9Sa/2012 dated 02.07.2013 (at Flag 'Z') as amended time to time, w.e.f. 27.12.2011 when his only child completed 10 years of age being his date of birth i.e., 27.12.2001 and he has completed 40 years of his age.

May if approved, the file may therefore kindly be laid before Hon'ble Mr. Justice S. K. Singh for His Lordship kind perusal and order to sanction personal pay under voluntary family programme equal to one increment or as fixed vide G.O. no. 650/II-4-2013-9Sa/2012 dated 02.07.2013 as amended time to time, w.e.f. 27.12.2011 to Sri Kailash Kumar, Civil Judge (Jr. Div.), Kairana, Muzaffarnagar and his Lordship may also be requested to sign draft sanction order placed below at the place cross marked with red pen.
