May kindly see the letter dated 29.05.2012 of Sri Kiriti Kunal, the then Additional Civil Judge (Jr. Div.), Ghazipur now Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sambhal, Moradabad duly forwarded by the District Judge, Moradabad through which he has submitted attested copies of LL.M. (I & II year) marksheets and attested copy of final degree of LL.M. (at Flags 'B', 'C' & 'D' respectively) to this Court regarding inclusion of qualification of LL.M. in his service records placed below at Flag ' A '.

It may be recalled that earlier Sri Kiriti Kunal sent an application dated 29.05.2009 (at Flag 'E') enclosed with attested copy of LL.M.-II year marksheet to this Court for inclusion of qualification of LL.M. and stated therein that he has joined U.P. Judicial Service on the post of Additional Civil Judge (Jr. Div.), Ghazipur on 18.05.2009 and he has qualified LL.M. examination on 13.04.09. He has also stated that prior to his appointment, he appeared in the examination of LL.M. on 2008. He has requested the Court for inclusion of qualification of LL.M. in his service records.

Then a Court's letter dated 30.01.2010 (at Flag 'F') was sent to the District Judge, Ghazipur with the request to ask Sri Kiriti Kunal, the then Additional Civil Judge (Jr. Div.), Ghazipur now Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sambhal, Moradabad to submit attested copy of final degree of LL.M., to this Court for necessary action.

In reply of Court's letter dated 30.01.2010, Sri Kiriti Kunal, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sambhal, Moradabad through his letter dated 29.05.2012 has sent attested copies of LL.M. (I & II year) marksheets and attested copy of final degree of LL.M., to this Court for necessary action in the matter.

In this connection it may be submitted that Sri Kiriti Kunal has completed his LL.M. from Purvanchal University, Jaunpur on 13.04.2009, prior to joining in U.P. Nyayik Sewa. He has joined U.P. Judicial Service on the post of Additional Civil Judge (Jr. Div.), Ghazipur on 18.05.2009.

In this connection, it is further submitted that Appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included

in the service records of Sri Kiriti Kunal with the permission of Government of U.P. as the appointing authority of Judicial Officers is Government of U.P. Therefore, it seems proper the application of Sri Kiriti Kunal, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sambhal, Moradabad regarding inclusion of qualification of LL.M. in his service records may be sent to the Government for obtaining orders.

If approved by Hon'ble Mr. Justice S.U. Khan, Administrative Judge, Moradabad copy of application dated 29.05.2009 and letter dated 29.05.12 of Sri Kiriti Kunal, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sambhal, Moradabad regarding inclusion of qualification of LL.M. in his service records, attested copy of final degree of LL.M., attested copies of marksheet of LL.M.(I & II year) and photocopy of form of U.P. Nyayik Sewa of Sri Kiriti Kunal may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. for obtaining necessary orders of the Government in the matter.
