May kindly see the letter, placed below at flag 'A', received from Smt. Tarannum Khan, Judicial Magistrate, Agra regarding issuance of 'Identity Certificate' for obtaining Passport.

In her letter, Smt. Tarannum Khan has stated that her father-in-law Sri Mohammad Asad resides at Saudi Arabia and she wants to visit him for which passport is required. She has enclosed four passport size photographs of herself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. Her dependents are Sri Abdullah (Husband) & Master Aayan (Son). She has, therefore, requested for issuance of 'Identity Certificate' for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). She has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Smt. Tarannum Khan. Her request is considerable, as she has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Devendra Pratap Singh, Administrative Judge, Agra Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Smt. Tarannum Khan, Judicial Magistrate, Agra as requested, for obtaining Passport with the direction that she should take prior permission of the Court before proceeding abroad?
