May kindly see the letter at flag 'A', received from Smt. Tarannum Khan, Chief Judicial Magistrate, Deoria regarding issuance of 'No Objection/ Identity Certificate' in her favour for obtaining Passport.

In her letter, Smt. Khan has stated that earlier NOC was issued in her favour on 25.03.2014 but the same could not be materialised due to personal reason (illness of father-in-law), accordingly No Objection Certificate dated 25.03.2014 became time barred. She has returned earlier issued No Objection Certificate (flagged at 'B') with the request to issue fresh one. Sri Abdullah (Husband), Master Ayaan (Son) and Baby Inaaya (Daughter) are dependent family members of the officer. She has also enclosed passport size photographs of herself and required details/ declaration on 'Affidavit', which may kindly be seen at flag 'C'. She has, therefore, requested for issuance of fresh 'No Objection/ Identity Certificate' in her favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'D'). Earlier, as per approval (flagged 'X') of Hon'ble Administrative Judge, Agra, 'No Objection Certificate' dated 25.03.2014 was issued in her favour (office copy is at flag 'E'), but as he has now requested for fresh 'Identity Certificate' due to the reason that earlier issued 'Identity Certificate' got expired as she could not applied for the passport due to due to personal reason (illness of father-in-law), her request may be considered. Here, it is also to submit that as per reports, placed below, no vigilance/ departmental enquiry is pending against Smt. Tarannum Khan. Her request is considerable, as she has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Ram Surat Ram (Maurya), Administrative Judge, Deoria, the 'Identity Certificate' at flag 'F' be issued, in duplicate, in favour of Smt. Tarannum Khan, Chief Judicial Magistrate, Deoria, as requested, for obtaining Passport with the direction that now she should apply for the passport within due time and that she should take prior permission of the Court before proceeding abroad?
