May kindly see the letters, placed below at flags 'A', 'B' & 'C', received from Smt. Tarannum Khan, Civil Judge (Jr. Div.), Bulandshahar regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Smt. Tarannum Khan has submitted the property statement of movable and immovable property for the financial years 2010-11, 2011-12 and 2012-13 through her letter dated 25.02.2016 (at flag 'B') but some information have not been found. Accordingly, a Court's letter dated 16.04.2016 (at flag 'D') has been sent to the District Judge, Bulandshahar with the request to kindly ask Smt. Tarannum Khan for giving the required details/information to the Court, so that further necessary action may be taken in the matter.

The officer has fulfilled required details through her letter dated 11.05.2016 (at flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

- (1) In the financial year 2009-10 (i.e., 16.05.2009 to 31.03.2016), the income from salary is Rs.2,18,394/- and from this amount, Rs.1,200/- is deducted against GIS, Rs.30,000/- deposited in her PPF a/c and Rs.50,000/- against FD. The balance of her savings bank account(s)

enhanced for Rs.21,864/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.1,03,064/-. Thus, a sum of Rs.1,15,330/- was therefore available with her to meet out the household expenditure of herself in ten months of the financial year.

(2) In the financial year 2010-11, the income from salary is Rs.4,14,554/- and from this amount, Rs.1,440/- is deducted against GIS, Rs.5,000/- deposited in her PPF a/c, Rs.25,000/- against SBI Mutual fund, Rs.17,684/- against Income Tax and Rs.1,90,000/- paid against purchase of Car. As such, total deductions/ repayment/ savings/ investment is Rs.2,39,124/-. The balance of her savings bank account(s) reduced for Rs.9,104/- this financial year. Thus, a sum of Rs.1,84,534/- was therefore available with her to meet out the household expenditure of herself in whole of the financial year.

(3) In the financial year 2011-12, the income from salary is Rs.6,01,512/- and from this amount, Rs.2,040/- is deducted against GIS, Rs.75,000/- against UTI Insurance plan, Rs.25,000/- against HDFC tax save, Rs.3,087/- deposited in her PPF account, and Rs.28,690/- against Income Tax. The balance of her savings bank account(s) enhanced for Rs.43,098/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.1,76,915/-. Thus, a sum of Rs.4,24,597/- was therefore available with her to meet out the household expenditure of her family consisting of two members in whole of the financial year.

Her husband Sri Abdullah is an Advocate and his ^{Income} salary is Rs.2,00,000/-.

(4) In the financial year 2012-13, the income from salary is Rs.2,45,011/- and from this amount, Rs.800/- is deducted against GIS, Rs.12,750/- against India First Smart save policy, Rs.5,173/- deposited

in her PPF account and Rs.2,082/- against Income Tax. As such, total deductions/ repayment/ savings/ investment is Rs.20,805/-. The balance of her savings bank account(s) reduced for Rs.22,598/- this financial year. Thus, a sum of Rs.2,46,804/- was therefore available with her to meet out the household expenditure of her family consisting of three members in whole of the financial year.

Her husband's ~~salary~~ income is Rs.2,00,000/-.

In this connection it is submitted that Smt. Tarannum Khan has already submitted her property statement at the time of joining into judicial service (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Devendra Pratap Singh, the then Administrative Judge, Meerut on 04.01.2013 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial year 2009-10 & 2010-11 in its next financial year i.e., 2011-12 upto march 2012, and 2011-12 & 2012-13 in its next financial year i.e., 2013-14 upto March 2014. She has submitted the movable and immovable property statement for the financial year 2009-10 vide her letter dated 14.10.2010 (at **flag 'C'**) and 2010-11, 2011-12 and 2012-13 vide her letter dated 25.02.2016 (at **flag 'B'**). As such, there is delay in submitting the property statements for the financial year 2010-11, 2011-12 and 2012-13 from the part of the officer for which she has regretted and stated that aforesaid property statement not submitted in time due to maternity & medical leave after that child care leave etc. in her letter dated 25.02.2016 (at **flag 'B'**).

May, therefore, if approved, the property statements for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 alongwith letters dated 11.05.2016 (at **flag 'A'**), 25.02.2016 (at **flag 'B'**) and 14.10.2010 (at **flag 'C'**) of Smt. Tarannum Khan, Civil Judge (Jr. Div.), Bulandshahar be laid

before Hon'ble Mr. Justice S. N. Shukla, Administrative Judge, Bulandshahar
