1. Processing fee of Rs/-500/- (125/- for SC/BC//BLIND Candidates of Haryana only) will be charged in addition to course fee for online admission. This fee shall be Rs.600/- for downloaded admission forms and the students purchasing prospectus will not be required to pay this fee.
 2. In the event of last date falling on a Holiday, as mentioned in the above Schedule, the next working day shall be treated as the last date.
 3. A candidate whose result of ANNUAL EXAMINATION (Not applicable for Compartment/Re-appear/Re-evaluation, UMC, Mercy chance cases, etc.) is declared late by the Kurukshetra University/Board of School Education Haryana, for no fault of his/her, if otherwise eligible, may be allowed admission to the corresponding higher class within 15 days of the date of dispatch of result card (as mentioned on the result card), without late fee, and after that the Admission Form (from A-C) shall be entertained with usual late fee provided that the candidate is in a position to fulfill the requirement of attendance in the PCP of the course at that stage.
 4. Admission will also be allowed to various courses to the candidates, who on declaration of their result of supplementary examination/compartments/re-appear/ re-evaluation become eligible for admission, during the session, with usual late fee but ordinarily up to such date as may be prescribed in the Prospectus from time to time provided that the Personal Contact Programme of the course is not yet over after that the Admission Form (from A-C) may be considered with usual late fee subject to the condition that the candidate is in a position to fulfill the requirement of attendance in the PCP of the respective course at that stage.
