May kindly see the letter, placed below at flag 'A', received from ^{Kom} ~~Smt~~ Ekta Verma, Additional Civil Judge (Jr. Div), Allahabad regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family at the time of entering into Judicial Service in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that the officer concerned has joined the U.P. Judicial Service on 06-06-2009. Earlier, ^{Kom} ~~Smt~~ Ekta Verma has submitted his movable and immovable property statement at the time of entering into Judicial Service through her letter dated 11-11-2010 (flagged 'A-1'). Thereafter she was asked to submit supplementary information as in her property statement acquired held by her on the date of her joining, she has mentioned Rs. 2,13,086/- as her salary which seems to be mentioned as nil, and if, any other source of income she had on the date of her joining other than from the Judicial service, the same may be mentioned accordingly in column no. 8 vide Court's letter dated 07-03-2011 (flagged 'C-1').

In reply of Court's letter dated 07-03-11 ^{Kom} ~~Smt~~ Ekta Verma has submitted her letter dated 11-03-2011 (flagged 'A') in which she has stated that she has no other source of income except the salary income and column no 9 may kindly be read as 'I have no other sources of income' instead of nil. .

May, therefore, if approved, the statements at the time of entering into Judicial Service alongwith letters dated 11-03-2011 (flagged 'A'), of ^{Kom} ~~Smt~~ Ekta Verma, Additional Civil Judge (Jr. Div), Allahabad be laid before Hon'ble Mr. Justice Dilip Gupta Administrative Judge, Allahabad Judgeship for his Lordship's kind perusal and orders?
