1. To provide the status of L.I.C. Policy in the financial years 2010-11, 2011-12 and 2012-13, as he has mentioned deposit against L.I.C. policy in the financial year 2009-10 property statement only and not thereafter.
2. A sum of Rs.67,438/-, Rs.1,84,657/- and 1,76,792/- was available with him to meet out the household expenditure of him in whole of the financial year 2009-10, 2010-11 and 2011-12 respectively. Thus, it is not clear how he managed his expenditure in the financial years 2009-10, 2010-11 and 2011-12. To clarify the actual position about the point raised with supporting papers.


