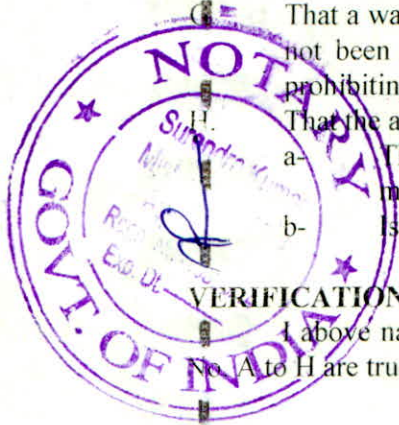

- G. That a warrant or summons for the appearance, or a warrant for the arrest of the applicant has not been issued by the court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- H. That the applicant has not been repatriated.
 - a- There is no possibility of arising embarrassing position before the government due to my visit to any foreign country.
 - b- Issuance of Identity certificate for obtaining a passport was never refused to me.
