May kindly see the letter dated 05.11.2009 of Khushtar Danish, Additional Civil Judge (Jr. Div.) ~~Amroha~~ JP Nagar (trainee Civil Judge) duly forwarded by the Director, Institute of Judicial Training & Research Uttar Pradesh, Lucknow, regarding forwarding the application form of Delhi Judicial Service Examination to the Delhi High Court and Certification of character in the proforma provided therein, placed below at Flag 'A' & 'B'.

Through his letter Khushtar Danish has stated that vide notification of the Hon'ble High Court at Allahabad he joined in the office at District Judge, Amroha (J.P. Nagar) on 08.06.2009 and presently undergoing induction level training at the I.J.T.R. Lucknow. He wish to appear in the Delhi Judicial service examination 2010. As per requirement of said examination form, every government servant is bound to forward the form to Delhi High Court through their concerned department alongwith certification of character in the prescribed proforma in the last page of the form.

He has further stated that the last date of receipt of the said form at Delhi High Court is **01.12.2009** and it will not be considered after the said date.

Therefore, he requested that to place the matter before Hon'ble Court so that the required certification at the last page of the form may be provided and also pray for the onward transmission of the said form in due time.

In this connection it may be submitted that Khushtar Danish is newly appointed Judicial Officer in the post of Additional Civil Judge, (Jr. Div.), Khushtar Danish and presently he is undergoing induction level training at the I.J.T.R. Lucknow and as such office has not obtained the report of departmental and vigilance inquiry if any so initiated against her.

In this connection it may also be submitted that in respect of forwarding of application of the U.P. Government employees to the other State, provision contained in para 2 and 3 of G.O. no.16/2/1968- Karmik-II, dated 19.06.1979, which are being reproduced herein as under in verbatim:-

- "2. इस संदर्भ में मुझे आप से यह कहने का निदेश हुआ है कि भविष्य में राज्य सरकार के अधिकारी कर्मचारी {स्थायी अथवा अस्थायी} संघ लोक सेवा आयोग के अतिरिक्त अन्य प्रदेशों के आयोगों द्वारा भी विज्ञापित पदों के लिए अपने आवेदन पत्र सीधे भेजने के लिए अधिकृत किये जाते हैं। संबंधित अधिकारी कर्मचारी आवेदन पत्र भेजने के तुरन्त बाद ही अपने विभागाध्यक्ष को विज्ञापित पद के संबंध में पर्याप्त सूचना देते हुए उन्हें इस तथ्य से अवगत करा देगा कि उसने आवेदन पत्र सीधे भेज दिया है। ऐसी सूचना प्राप्त होने पर विभाग विभागाध्यक्ष अपनी अनापत्ति/आपत्ति के बारे में संघ लोक सेवा आयोग/अन्य प्रदेशों के आयोगों को सूचित कर देंगे। यह सूचना संबंधित अधिकारी/कर्मचारी के विभागाध्यक्ष द्वारा संबंधित आयोग को उसके द्वारा आवेदन पत्र प्राप्त करने की निर्धारित अन्तिम तिथि के 30 दिन के अन्दर पहुँच जाने हैं। यदि उक्त प्रकार की सूचना संघ लोक सेवा आयोग अन्य प्रदेशों के आयोगों को उपरिलिखित अवधि के अन्दर नहीं दी जाती तो संबंधित आयोग द्वारा यह मान लिया जाएगा कि विभाग/विभागाध्यक्ष को कोई आपत्ति नहीं है और उस अधिकारी/कर्मचारी अभ्यर्थित्व पर आयोग द्वारा विचार कर लिया जाएगा।

3. जहां तक प्रदेश के बाहर {चाहे वह केन्द्रीय सेवा का मामला हो या, अन्य राज्य सरकार का} पदों के लिए आवेदन पत्रों पर अनापत्ति प्रमाण पत्र देने का प्रश्न है, इस बात पर ध्यान रखना आवश्यक होगा कि विभागाध्यक्ष विभाग इस बात का मूल्यांकन कर लेंगे कि क्या अपने जनशक्ति साधन को प्रदेश के बाहर भेजना हितकर होगा अथवा नहीं। तदनुसार विभागाध्यक्ष विभाग अपने विवेकानुसार अनापत्ति प्रमाणपत्र देने के पूर्व उक्त स्थिति को दृष्टिगत रखेंगे और यदि वह यह समझते हैं कि वह अपने प्रदेश के जनशक्ति साधन को इस प्रकार खोना विभागीय हित में नहीं होगा तो यही कारण बताते हुए वह संघ लोक सेवा आयोग, अन्य प्रदेशों के आयोगों को निर्धारित समय के अन्दर अवश्य ही सूचित कर देंगे।"

In the another case of Sri Nipun Awasthi newly appointed Civil Judge(Jr.Div.) Azamgarh (under trainee) who resigned from the post of Civil Judge(Jr.Div.) recently, the Hon'ble Chief Justice has given some instructions which are also being reproduced herein as under:

"A judicial officer before he is assigned Judicial work has to necessarily undergo training.

If he does not serve after training due to resignation during training period, the salary and other emoluments paid to him and the expenditure incurred on his training go waste and futile.

In order to overcome this, from the next year's appointment, will it not be advisable to incorporate a rule and insert condition in the advertisement that the resignation of an officer during training period or within 2 years of joining shall not be accepted unless he deposits the amount received as salary and the amount spent on his training or a consolidated amount.

Matter may be placed before appropriate Committee."
