May kindly see the letter, placed below at flags 'A-2', received from Sri Khushter Danish, Additional Civil Judge (Junior Division), Kairana, Muzaffarnagar, by which he has submitted a copy of his licence of Revolver/ Pistol (flag 'X') in connection with grant of permission to purchase a Revolver.

In this connection, it is submitted that earlier Sri Danish through his letters dated 13.04.2012 (flag 'A') and 19.07.2012 (flag 'A-1') has requested for grant of permission to purchase a Revolver by saying that it will cost approximately Rs. 1,10,774/-. He joined U.P. Judicial Service on 08.06.2009, his gross salary is Rs. 46,716/-. For purchase of the said Revolver, he incurred a personal loan of Rs. 1,10,000/- (Certificate of loan is at flag 'B'), repayable in monthly installment of Rs. 3,034/-. He intend to purchase Revolver from Small Arms Factory, Kalpi Road, Kanpur. He has also stated that since he tendered his application for grant of license from the Competent Authority in June 2009 prior permission in terms of Circular letter no. 11/ IVh-16/ Admin (A) dated 12.04.2010 could not be obtained. Accordingly the matter was submitted before Hon'ble Mr. Justice Sanjay Misra through an office note dated 16.08.2012 (flag 'X-1') upon which His Lordship has been pleased to pass order dated 03.10.2012 that **the officer may be asked to inform as to whether the licence has been granted to the officer by the licensing authority or not and if so, a copy thereof may also be sent.**

The order was communicated to the officer through Court's letter dated 10.10.2012 (flag 'X-2').

Now, in reply of Court's letter dated 10.10.2012, Sri Khushter Danish, through his letter dated 29.11.2012 (flag 'A-2') has submitted that licence regarding Revolver has been granted to him by the licensing authority, which has been annexed (flag 'X'). He has, therefore, again requested for placing his application before the Hon'ble Court for grant of permission to purchase a Revolver.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and orders to the effect that Sri Khushter Danish, Additional Civil Judge (Junior Division), Kairana, Muzaffarnagar may be accorded permission to purchase a Revolver from Small Arms Factory, Kalpi Road, Kanpur, as requested, subject to the condition that he will submit full pointwise details and papers of the purchase after completion of the purchase transaction immediately, under C.L. no. 25/ Admin (A) dated 13.07.1998?
