May kindly see the letter, placed below at **flag 'A'**, received from Sri Pradeep Kumar, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Lakhimpur-Kheri regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2009-10 & 2010-11, the income from salary is Rs.7,33,008/- and from this amount, Rs.2,400/- is deducted against GIS, Rs.26,262/- against Income Tax, Rs.20,000/- against NSC, Rs.15,008/- against premium of LIC policies, Rs.87,718/- paid against purchase of Car, Rs.20,560/- against Car loan and Rs.90,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.17,899/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.2,79,847/-. Thus, a sum of Rs.4,53,161/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2009-10 and 2010-11.
- (2) In the financial year 2011-12 & 2012-13, the income from salary is Rs.13,59,354/- and from this amount, Rs.6,960/- is deducted against GIS, Rs.67,836/- against Income Tax, Rs.70,253/- against CPF, Rs.73,000/- against NSC, Rs.2,15,008/- against Premium of LIC policies, Rs.98,688/- against Car loan and Rs.1,70,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.1,67,598/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.8,69,343/-. Thus, a sum of Rs.4,90,011/- was therefore available with him to meet out the household expenditure of his family consisting of four

members in whole of the financial years 2011-12 and 2012-13.

In this connection it is submitted that Sri Pradeep Kumar has already submitted his property statement at the time of entering into judicial service (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Vinod Prasad, the then Administrative Judge, Pilibhit on 02.02.2011 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2009-10 & 2010-11 in its next financial year i.e., 2011-12 up to March 2012, and 2011-12 & 2012-13 in its next financial year i.e., 2013-14 up to March 2014. He has submitted the movable and immovable property statement for the financial year 2009-10, 2010-11, 2011-12 and 2012-13 vide his letter dated 17.12.2015.
