

May kindly see the application dated 11-2-09 of Sri Farrukh Imam Siddiqui, Addl Civil Judge (Junior Division), Ballia, duly forwarded by the District Judge, Ballia regarding counting of previous service with his present service in U.P. Nyaayik Sewa for the purpose of pensionary benefit, please below, at the foot.

In his aforesaid application Sri Siddiqui has stated that at present he is posted as Addl Civil Judge (Junior Division), Ballia from 07.07.2009 and before joining this service he rendered his services on the post of District Youth Welfare / PRD Officer from 05-01-2001 to 06-07-2009. That after being relieved from previous department on 06.7.09 in the person he has joined the U.P. Nyaayik Sewa on 07-09-2009. He has further stated that during the period of his posting / service as District Youth Welfare Officer a deduction in the shape of G.P.F. was being made by him in G.P.F. Account No. bearing No. N.E.U - 4446.

Now he has requested the Deptt that previous services rendered by him on the post of District Youth Welfare & PRD Officer with effect from 05-01-2001 to 06-07-2009 may kindly be counted with his present service in U.P. Nyaayik Sewa.
