



May kindly see the letters, placed below at flag 'A', received from Sri Raghvendra Mani, Addl. Civil Judge(Jr. Div.), Ambedkarnagar for grant of permission to join LL.M from Kurukshetra University, Kurukshetra through as a Correspondence Course.

In his letters, Sri Raghvendra Mani has stated that he wants to take Admission to do Master of Laws (LL.M), as (Distance Learning) Course from Kurukshetra University, Kurukshetra in the academic Session 2010-11.

In the instant case, it is to mention that the officer has joined the Judicial Service on 17.8.09. He wants to pursue LL.M. from the Kurukshetra University, Kurukshetra. Acceptance of his request for doing the course of LL.M. from Kurukshetra University, Kurukshetra through Distance Learning Course(Correspondence Course) may be considered as there appears to be no necessity to join any classes, but it is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No.24/1066-Appointment (B) dated 21.08.1967(copy at flag X), subject to the following conditions:-

- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.
