May kindly see the letter dated 23.05.18 (placed below) of Smt. Jyoti, Secretary, District Legal Services Authority, Siddharth Nagar regarding inclusion of LL.M. qualification in her service records.

At the outset, it is relevant to mention here that earlier Smt. Jyoti sent an application dated 24.08.2017 (at flag 'A') to this Court and stated therein that she has completed LL.M in the year 2010 from Ch. Charan Singh University, Meerut and requested the Court for inclusion of the same in her service record. In reply to which, through this Court letter dated 27.11.2017 (at flag 'B') she was informed to submit attested copy of marksheets and Degree of LL.M. for further necessary action in this regard. She has enclosed attested copy of marksheet and degree of LL.M. alongwith her instant letter dated 23.05.18 and again requested for inclusion of LL.M. degree in her service record.

In this connection, it is submitted that Smt Jyoti, Secretary, District Legal Services Authority, Siddharth Nagar has joined U.P. Nyayik Sewa on 19.12.2009 (at Flag 'C'). She has completed LL.M. form Ch. Charan Singh University, Meerut in the year 2010 after joining the service under the permission of the Hon'ble Court (at Flag 'D') and attested copies of marksheet and degree of LL.M are placed at Flag 'E' & 'F' respectively.

It is further submitted that appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included in the service records of Smt. Jyoti, Secretary District Legal Services Authority, Siddharth Nagar with the permission of Government of U.P., Lucknow. Therefore, it seems proper that the aforesaid application of Smt. Jyoti regarding inclusion of degree of LL.M. in her service records may be sent to Government of U.P. for obtaining necessary orders.

Nyayik Sewa of Smt. Jyoti may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government in the matter?
