May kindly see the letters dated 21.11.2011 & 20.12.2011, placed at flag 'A' & 'A-1', received from Sri Sudesh Kumar, Additional Civil Judge, (Junior Division), Lucknow, regarding issuance of 'No Objection Certificate' for obtaining Passport.

In his letters, Sri Sudesh Kumar has stated that he wishes to apply for passport, for which he requires a 'No Objection Certificate from the Hon'ble High Court. He has also giving following required information as per circular letter issued by Hon'ble High Court :-

- 1 There is no possibility of any embarrassing position either for the Government of India or the Government of U.P. due to his foreign visit.
 - 2 He has never applied for 'No Objection Certificate' prior to this and no such request has never been refused to him.
 - 3 He has never visited any foreign country till date.
- He has, therefore, requested for issuance of 'No Objection Certificate' for himself, for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). As per reports, placed below, no vigilance/departmental enquiry is pending against Sri Sudesh Kumar. Now, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Abdul Mateen, Administrative Judge, Lucknow, the 'No Objection Certificate' at flag 'C' be issued, in favour of Sri Sudesh Kumar, Additional Civil Judge, Lucknow for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
