May kindly see the letter, placed below at flag 'A' received from Sri Sudesh Kumar, Civil Judge (Jr. Div.), Budaun, regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2009-10, 2010-11, 2011-12 & 2012-13, in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Sudesh Kumar had submitted his movable & immovable property statements of the financial years 2009-10, 2010-11, 2011-12 & 2012-13 through his letter dated 21-03-2014 (flagged 'A'). Thereafter he was asked to disclose the annual income of his wife in the financial years 2009-10, 2010-11, 2011-12 & 2012-13, vide Court's letter dated 28-04-2014 (flagged 'C').

Now, Sri Sudesh Kumar has submitted required informations through his letter dated 31-05-2014 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property of the financial years 2009-10, 2010-11, 2011-12 & 2012-13, of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:-

(1) In the financial year 2009-10, the income from salary is Rs.46,750/- for two months as he had joined that year on 02-01-2010, from this amount his deductions was Rs.2400/- as GIS, As such, total deductions /repayment/ savings/ investment is Rs.2400/-. Thus, a sum of Rs.44,350/- was therefore available with him to meet out the household expenditure of his family consisting of four members in two months of the financial years 2009-10

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Sudesh Kumar is reduced to Rs.8,503/- against balance of previous year and his wife Smt. Ranjana is Prop. of M/S Panch Sheel Filling Station Sahabad, Rampur and her annual income is Rs.2,02,065/-

(2) In the financial year 2010-11, the income from Gross salary is Rs.04,76,423, and from this amount, Rs.47,474/- is deducted against CPF,

Rs. 1440/- against GIS, Rs.20,399/- against IT, Rs.85,934/- against LIC, Rs.60,000/- against repayment of car loan and Rs.1,000/- purchased NSC. The balance of his savings bank account (s) enhanced for Rs.1,62,171/- (including interest). As such, total deductions /repayment /savings/ investment is Rs.03,78,418/-. He has also received Rs.67,842/- from from the policy no. 06975919, Rs.40,025/- from the maturity of NSC and Rs.57,750/- from agricultural income. Thus, a sum of Rs.02,63,622/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2010-11.

However, it is pertinent to mention here that his wife's annual income is Rs.2,11,713/-

(3) In the financial year 2011-12, the income from Gross salary is Rs.05,95,573, and from this amount, Rs.55,608/- is deducted against CPF, Rs.2000/- against GIS, Rs.29,391/- against IT, Rs.85,934/- against LIC, Rs.60,000/- against repayment of car loan and Rs.30,000/- purchased NSC. The balance of his savings bank account (s) enhanced for Rs.1,83,444/- (including interest). As such, total deductions /repayment /savings/ investment is Rs.04,46,377/-. He has also received Rs.32,020/- from the maturity of NSC and Rs.71,500/- from agricultural income. Thus, a sum of Rs.02,52,716/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2011-12.

However, it is pertinent to mention here that his wife's annual income is Rs.2,29,960/-

(4) In the financial year 2012-13, the income from Gross salary is Rs.05,82,982, and from this amount, Rs.57,756/- is deducted against CPF, Rs.2400/- against GIS, Rs.29,343/- against IT, Rs.85,934/- against LIC, Rs.60,000/- against repayment of car loan and Rs.41,600/- purchased NSC. The balance of his savings bank account (s) enhanced for Rs.1,61,689/- (including interest). As such, total deductions /repayment /savings/ investment is Rs.04,46,377/-. He has also received Rs.94,490/- from agricultural income. Thus, a sum of Rs.02,38,750/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2012-13.

However, it is pertinent to mention here that his wife's annual income is Rs.3,58,276/-

In this connection it is submitted that Sri Sudesh Kumar, has already submitted his property statement at the time of entering into Judicial Service (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Abdul Mateen the then Administrative Judge, Lucknow at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2009-10 & 2010-11 in its next financial year i. e. in 2011-12 up to March 2012. He has submitted the same through letter dated 21-03-2014 and as such, there is delay in submitting the said statements and his property statement for the years 2011-12 & 2012-13 in its next financial year i. e. in 2013-14 up to March 2014. He has submitted the same through letter dated 21-03-2014 and as such, there is no delay in submitting the said statements

May, therefore, if approved, the property statements for the financial years 2009-10, 2010-11, 2011-12 & 2012-13 alongwith letters dated 21-03-14 & 31-05-2014 (flagged 'A' & 'A-I' ) of Sri Sudesh Kumar, Civil Judge (Jr. Div.), Budaun, be laid before Hon'ble Mr. Justice Dinesh Maheshwari, Administrative Judge, Budaun judgeship for His Lordship's kind perusal and orders?
