May kindly see the letter dated 14.6.17 (at flag 'A') of Smt. Lovely Jaiswal, Additional Civil Judge(Sr.Div.), Mathura by which she has submitted the property statements for the financial years 2015-16 and 2016-17.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2015-16 and 2016-17 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the statement of movable and immovable property for the financial year 2015-16, Smt. Jaiswal's total Income from salary is Rs.8,75,521/- from this amount, she has paid Rs.2400/- against GIS, Rs.33,851/- against CPF, Rs.57,942/- against Income Tax, Rs.36,857/- against LIC, Rs.80,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.46,184/- this financial year. As such, total deductions /Savings/investment is Rs.2,57,234/-. Thus a sum of Rs.6,18,287/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial years 2015-16.

(2) In the statement of movable and immovable property for the financial year 2016-17, Smt. Jaiswal's total Income from salary is Rs.9,88,121/- from this amount, she has paid Rs.2400/- against GIS, Rs.1,29,539/- against CPF, Rs.80,776/- against Income Tax, Rs.36,857/- against LIC, Rs.70,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.35,337/- this financial year. As such, total deductions /Savings/investment is Rs.3,54,909/-. Thus a sum of Rs.6,33,212/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial years 2016-17.

It is pertinent to mention here that the husband of the officer Sri Indrajeet Singh is also Civil Judge(Jr.Div.) whose annual salaries are Rs.8,39,468/-(in the financial year 2015-16), Rs.9,68,668/-(in the financial year 2016-17).

In this connection, it is submitted that Smt. Jaiswal has already submitted her property statement upto the financial year 2014-15 which was seen by Hon'ble Mr. Justice D.K.Arora, the then Administrative Judge, Mathura on 29.8.16 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2015-16 and 2016-17 has been submitted by the officer vide her letter dated 14.6.17 (flag 'A'). The property statement for the financial years 2015-16 and 2016-17 was due to be submitted in the financial year 2017-18 i.e. on or before 31.3.18. As such there is no delay in submitting the property statement for the aforesaid period from the part of the officer.
