It may be recalled that earlier Km Lovely Jaiswal ^(Chas B) sent an application on 09-11-2009 to this court for inclusion of qualification of LL.M in her service records and stated therein that she has passed the LL.M (Final) exams from Lucknow University and received marksheet on 07-2-2009. It happens before her appointment to the post of Civil Judge (Jr Div) on 22-04-2009 as per notification no 1539/II-09-32(1)/2002. She has requested the court for inclusion of qualification of LL.M in her service records.

In this connection it may be submitted that Lovely Jaiswal has got the appointment in U.P. Nyaayik sewa through the Notification No 1539/II-04-32(1)/2008 dated 22-04-2009 and she has joined the U.P. Nyaayik sewa on the post of Addl Civil Judge (Junior Division), Gonda on 17-12-2009. She has completed her LL.M from Lucknow University before appointment in U.P. Nyaayik sewa.

In this connection it may also be submitted that Appointing authority of Judicial officers of U.P. Nyaayik sewa is Government of U.P. The qualification of LL.M may be added in the service records of Lovely Jaiswal with the permission of Government of U.P. Therefore it seems proper that aforesaid application of Lovely Jaiswal, Addl Civil Judge (Junior Division), Gonda regarding inclusion of qualification of LL.M may be sent to the Government
