May Kindly see the letter, placed below at flag 'A & 'A-1', received from Km. Alka Chaudhary, Additional Civil Judge (Junior Division), Muzaffarnagar by which she has requested for grant of permission to appear in U.P. Provincial Civil Services (Main) Examination, 2009.

In her earlier letter dated 30-09-2010 (flagged 'A'), Km. Alka Chaudhary had stated that she wants to appear in the U.P. Provincial Civil Services (Main) Examination, 2009. The proposed date of the aforesaid examination is 29th November 2010 and the last date of the submission of application of the aforesaid examination is 11th October 2010. She has further stated that she is submitting the application form of the aforesaid examination in anticipation of permission of Court. She has, therefore, requested the Court to grant her permission to appear in the said examination. On receipt of her application letter she was asked vide Court's letter dated 12-10-2010, to inform as to whether she had taken permission for appearance in U.P. Civil Service (Prelim) examination - 2009 and the date of the preliminary examination held of the said exam.

Now, in reply, Km. Alka Chaudhary, vide his letter dated 14-10-2010 (flag 'A-1') has informed that the Prelim. Exam of the said examination was conducted on 13-12-2009 and she appeared in the Civil Services (Preliminary) Examination 2009 before her joining of U.P. Judicial Service on 19-12-2009.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa vide Court's Notification dated 17-12-2009, as on 19-12-2009, as stated Permission to appear in such type of written examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
