May kindly see the letter, placed below at flag 'A', received from Km. Alka Chaudhary, Additional Civil Judge (Junior Division), Muzaffarnagar by which she has requested for grant of permission to appear in U.P. Provincial Civil Services (Pre.) Examination, 2012.

In her letter (flagged 'A'), Km. Alka Chaudhary had stated that she wants to appear in the U.P. Provincial Civil Services (Pre.) Examination, 2012. The last date of the submission of application of the aforesaid examination is 24th February 2012. She has further stated that she is submitting the application form of the aforesaid examination in anticipation of permission of Court. She has, therefore, requested the Court to grant her permission to appear in the said examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa vide Court's Notification dated 17-12-2009, as on 19-12-2009, as stated. It is desirable that she may be accorded permission to appear in preliminary examination of U.P. Provincial Civil Services (Pre.) Examination, 2012, if the Court desire. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect her normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Sibghat Ullah Khan, Administrative Judge, Muzaffarnagar Judgeship, permission be accorded to Km. Alka Chaudhary, Additional Civil Judge (Junior Division), Muzaffarnagar to appear in U.P. Provincial Civil Services (Pre.) Examination, 2012, as requested, subject to the conditions mentioned above?
