The order of the Court had been communicated to the officer concerned vide Court's letter dated 03-08-2013 (flagged 'DD').

In reply of the Court's letter the officer concerned has replied vide his letter dated 21-09-13 duly forwarded the District Judge, Bijnor through endt. no. 1424/I/2012-Admin-I dated 25-09-2013, which is at flag 'DD' and reproduced below in verbatim :-

**(1) Details as required in Col. No.4 of the proforma:**

(i) My mother had got purchased me a Scooter No.UP 21H-1333 in the year 1999 and thereafter she had got purchased me a Hero Honda Karizma( bike) NoUP.21W-8595 in the year 2007.

(ii) The house -hold articles worth Rs. 4,75,000/- were acquired in the year 2004 by the parents at the time of my marriage and a jewellery of Rs. 7,50,000/- was also acquired in the year 2004 at the time of my marriage..

(iii)-I have purchased a Maruti Dzire Car no. U.P. 23E-8181 for a sum of Rs. 6,50,000/- in the month of April, 2009 after selling the old car and taking loan from State Bank Of India.
