May kindly see the letter dated 3.11.2015 (at flag 'A') of Sri Manoj Kumar-II, Civil Judge(Jr.Div.), Bansi, Siddharth Nagar by which he has submitted the property statement for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial years 2009-10(i.e. 22.12.09 to 31.3.10) , Sri Manoj Kumar's gross Income from salary is Rs.1,80,815/- from this amount, he has paid Rs.2160/- against GIS, Rs.13,387/- against CPF, Rs.25,000/- against Insurances, Rs.5,000/- against PPF and Rs.19,000/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.22.233/- this financial year. As such, total deductions /Savings/investment is Rs.64,547/-. Thus a sum of Rs.1,57,501/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial years 2009-10.

(2)In the statement of movable and immovable property for the financial years 2010-11, Sri Manoj Kumar's Income from salary and other Sources is Rs.5,86,812/- from this amount, he has paid Rs.4800/- against GIS, Rs.37,000/- against Insurances, Rs.30,000/- against PPF, Rs.25,000/- against NSC and Rs.70,861/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.1,92,040/- this financial year. As such, total deductions /Savings/investment is Rs.3,59,701/-. Thus a sum of Rs.2,27,111/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial years 2010-11.

- (3) In the statement of movable and immovable property for the financial years 2011-12, Sri Manoj Kumar's Income from salary and other Sources is Rs.5,84,239/- from this amount, he has paid Rs.93,302/- against CPF, Rs.4240/- against GIS, Rs.25,000/- against Insurances, Rs.37,000/- against PPF, Rs.35,000/- against NSC, Rs.27,938/- against Income Tax and Rs.51,793/- towards car loan. As such, total deductions /Savings/investment is Rs.3,59,701/-. The balance of his Saving Bank Account(s) decreased for Rs.32,859/- this financial year. Thus a sum of Rs.2,74,273/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the financial years 2011-12.
- (4) In the statement of movable and immovable property for the financial years 2012-13, Sri Manoj Kumar's Income from salary and other Sources is Rs.7,98,578/- from this amount, he has paid Rs.65,347/- against NPS, Rs.3600/- against GIS, Rs.23,502/- against Income Tax, Rs.77,200/- against Insurances, Rs.35,000/- against NSC, Rs.23,502/- against Income Tax and Rs.66,235/- towards car loan. The balance of his Saving Bank Account(s) enhanced for Rs.1,66,789/- this financial year. As such, total deductions /Savings/investment is Rs.4,37,673/-. Thus a sum of Rs.3,60,905/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2012-13.
- (5) In the statement of movable and immovable property for the financial years, 2013-14, Sri Manoj Kumar's Income from salary and other Sources is Rs.10,63,475/- from this amount, he has paid Rs.2200/- against PRAN, Rs.2200/- against GIS, Rs.59,126/- against Income Tax, Rs.22,000/- against PPF, Rs.58,875/- against LIC, Rs.40,200/- against PLI, Rs.59,126/- against Income Tax and Rs.1,04,934/- towards car loan. As such, total deductions /Savings/investment is Rs.3,41,314/-. The balance of his Saving Bank Account(s) decreased for Rs.10,000/-(approx.) this financial year. Thus a sum of Rs.7,22,161/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2013-14.

(6)In the statement of movable and immovable property for the financial years 2014-15, Sri Manoj Kumar's Income from salary and other Sources is Rs.8,86,240/- from this amount, he has paid Rs.1,02,120/- against PRAN, Rs.2400/- against GIS, Rs.82,600/- against Income Tax, Rs.28,000/- against PPF, Rs.1,60,500/- against LIC, Rs.40,252/- against PLI, Rs.82,600/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.3,24,471/- this financial year. As such, total deductions /Savings/investment is Rs.7,40,343/-. Thus a sum of Rs.1,45,897/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2014-15.

In this connection, it is submitted that Sri Manoj Kumar-II has already submitted his property statement of at the time of entering into U.P. Judicial Service which was seen by Hon'ble Mr. Justice Abhinava Upadhya, the then Administrative Judge, Fatehpur on 20.8.13 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial year 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 3.11.15 (flag 'A'). The property statement for the financial years 2009-10 and 2010-11 was due to be submitted in the financial year 2011-12 i.e. on before 31.3.12, property statement for the financial years 2011-12 and 2012-13 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14 and property statement for the financial years 2013-14 and 2014-15 was due to be submitted in the financial year 2015-16 i.e. on before 31.3.16. As such there is delay in submitting the for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 from the part of the officer for which officer has stated that he humbly request that he, inadvertently could not submit the aforesaid statement earlier.

May, if approved, the statements of movable and immovable property—for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15—of Sri Manoj Kumar-II, Civil Judge(Jr.Div.), Bansi, Siddharth Nagar may kindly be laid before Hon'ble Mr. Justice B.K.Srivastava-II, Administrative Judge, Siddharth Nagar Judgeship for His Lordship's kind perusal and orders?
