- Whether three advance increments are admissible to all the Judicial Officers (any cadre in service or retired) already possessing LL.M degree on 21.03.2002.
- Whether three advance increments are admissible to those Judicial Officers also who acquire LL.M degree after 21.03.2002.
- Whether three advance increments are admissible ^{to} only those Civil Judges (Jr.Div.) and officers of H.J.S (Direct recruit) who possessed LL.M degree at the time of selection to the service and who have mentioned this qualification in the application form submitted to the Public Service Commission/High Court, Allahabad.
- Whether three advance increments are admissible to only those Civil Judges (Jr.Div.) and officers of H.J.S (Direct recruit) who possessed LL.M degree at the time of selection to the service as on 21.03.2002 or thereafter.
- Whether the officers so entitled three advance increments under Govt. Order no. 1363/II-4-2009-45(12)/91 T.C., dated 13.05.2009 may also be entitled of Dearness Allowance on the three increments.

I am, therefore, to request you kindly to move the Government to issue necessary clarification on the above point at an early date so that necessary steps for implementation of Government Order may be taken.
