May kindly see the letter, placed below at **flag 'A-1'**, received from Sri Satya Prakash Arya, Civil Judge (Sr. Div.), F.T.C., Sant Kabir Nagar by which he has furnished the reply, in compliance of order of Hon'ble Mr. Justice Virendra Kumar-II, Administrative Judge, Sant Kabir Nagar in the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier Sri Satya Prakash Arya had submitted his movable & immovable property statements at the time of entering into judicial service and for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 which were put up before Hon'ble Administrative Judge, Sant Kabir Nagar through detailed office note dated 04.10.2017 (at **flag 'Z'**) on which His Lordship has been pleased to pass the following order:

**"Let a comments be called for from the officer concerned within fifteen days as to why property statements has not been submitted at the time of entering into the service and delayed property statement has been submitted now."**

The order of the Court had been communicated to the officer concerned vide Court's letter dated 07.11.2017 (at **flag 'A-2'**).

In reply of the Court's letter, the officer concerned has replied through his letter dated 30.11.2017 (at **flag 'A-1'**) in which he has stated that he has joined the service on 21<sup>st</sup> December, 2009, his first phase of Induction training commenced from 3<sup>rd</sup> January, 2011 to 2<sup>nd</sup> April, 2011 and in the above period, he was just focussing on job & the environment in which he have to work, as very much new to the Court Environment. He has also stated that he got married on 7<sup>th</sup> December 2010, after which he tried to make adjustment with his professional & personal life at the same time. He has also stated that there is delay in submitting property statements just because of maintaining the work life balance and requested to pardon the dealy caused by him due the reasons & circumstances stated above.
