May kindly see the letter, placed below at **flag 'A-1'**, received from the District Judge, Sant Kabir Nagar through which he has forwarded the reply/letter dated 18.04.2018 (at **flag 'A-2'**) of Sri Satya Prakash Arya, Civil Judge (Sr. Div.), F.T.C., Sant Kabir Nagar, in compliance of order of Hon'ble Mr. Justice Virendra Kumar-II, Administrative Judge, Sant Kabir Nagar in, the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier Sri Satya Prakash Arya had submitted his movable & immovable property statements at the time of entering into judicial service and for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 which were put up before Hon'ble Administrative Judge, Sant Kabir Nagar through detailed office note dated 04.10.2017 (at **flag 'Z'**) on which His Lordship has been to the officer concerned vide Court's letter dated 07.11.2017 (at **flag 'B-1'**)

In reply of the Court's letter, the officer concerned has replied through his letter dated 30.11.2017 (at **flag 'A-3'**) but after perusal of the explanation submitted by the officer, His Lordship has been again pleased to pass the order dated 30.01.2018 (at **flag 'C-2'**) on the office note dated 10.01.2018 (at **flag 'C-2'**), which has been communicated the officer concerned vide Court's letter & reminder dated 07.02.2018 & 21.02.2018 (at **flags 'B-2' & 'B-3'** respectively). In reply of aforesaid Court's letters, District Judge has submitted his comments vide his letter dated 24.02.2018 (at **flag 'A-4'**) which were put up before Hon'ble Administrative Judge, Sant Kabir Nagar through office note dated 16.03.2018 (at **flag 'C-3'**) on which His Lordship has been pleased to pass the following order dated 23.03.2018 (at **flag 'C-3'**):

" The DJ may ask the officer to submit explanation within 15 days otherwise suitable orders shall be passed."

The order of the Court had been communicated to the officer concerned vide Court's letter dated 02.04.2018 (at **flag 'B-4'**).

In reply of the Court's letter, the officer concerned has replied through his letter dated 18.04.2018 (at **flag 'A-2'**) in which he has stated that he entered into the services in Civil Judge (Jr. Div.) cadre on 21.12.2009 after working for one year in Court, he has been nominated for 1st phase of Induction Training scheduled from 3rd January 2011 to 2nd April 2011. During the month of February 2011 (training's first phase), his father has been admitted & gone through surgery due to suffering from Neuro problem. As he has the only son of his parents has to manage family responsibility as well as training schedule in JTRI.

Being new into the service and due to lack of guidance unable to furnish his property details at the time of entering into this service. During the training's second phase (from 8th August 2011 to 7th November 2011), he got stressed both in his personal & professional life due to his matrimonial life crops up. During the above phase in his life he has been transferred from Meerut, Lakhimpur Kheri, Chandauli, sant Kabir Nagar. He has also stated that his mother went to surgery during his posting in Lakhimpur Kheri in february 2013, his father too get fracture operation of shoulder in october 2014 and he was under treatment in K.G.M.C., Lucknow due to lot of stress gone through depression. In the aforesaid circumstances, he was unable to send the property statements to the Hon'ble Court and requested to pardon the delay.

May, therefore, if approved, letter/reply of Court's Order as desired by the Court in the matter, furnished by the officer dated 18.04.2018 (at flag 'A-2') of Sri Satya Prakash Arya, Civil Judge (Sr. Div.), F.T.C., Sant Kabir Nagar be laid before Hon'ble. Mr. Justice Rajiv Lochan Mehrotra, Administrative Judge, Sant Kabir Nagar for His Lordship's kind perusal and orders?
