May kindly see the letter dated 19.9.2015 (at flag 'A') of Sri Kuldeep Singh-III, Additional Civil Judge(Jr.Div.), Shahjahanpur by which he has submitted his revised Statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15.

Earlier Sri Kumar has submitted the property statements for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 vide his letter dated 20.7.2015(flag 'B') in which he has not mentioned the details of deductions of his Salary i.e. CPF, GIS, date of taking loan and its EMI, amount deposited in PPF A/c and date of purchase of NSC, hence a Court letter dated 26.8.15(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, Officer has submitted the revised property statements for the aforesaid periods vide his letter dated 19.9.2015(flag 'A').

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- (1) In the statement of movable and immovable property for the financial year 2009-10,(from 19.12.2009 to 31.3.2010) Sri Singh's Total Income from Salary is Rs.56,836/- from this amount, he has paid Rs.360/- against GIS. The balance of his Saving Bank Account(s) enhanced for Rs.5,547/- this financial year. As such, total deductions /Savings/investment is Rs.5,907/-. Thus a sum of Rs.50,929/- was therefore available with him to meet out the household expenditure of his family consisting of only one member in financial year 2009-10.
- (2) In the statement of movable and immovable property for the financial year 2010-11, Sri Singh's total Income from Salary is Rs.4,24,739/- from this amount, he has paid Rs.24,581/- against CPF, Rs.1440/- against GIS, Rs.23,200/- against Income Tax, Rs.36,822/- towards Car loan. The balance of his Saving Bank Account(s) enhanced for Rs.21,759/- this financial year. As such, total deductions /Savings/investment is Rs.1,07,802/-. Thus a sum of Rs.3,16,937/- was therefore available with him to meet out the household expenditure of his family consisting of only one member in financial year 2010-11.
- (3) In the statement of movable and immovable property for the financial year 2011-12, Sri Singh's total Income from Salary is Rs.6,46,146/- from this amount, he has paid Rs.81,111/- against CPF, Rs.2160/- against GIS, Rs.38,150/- against Income Tax, Rs.20,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.1,53,749/- this financial year. As such, total deductions /Savings/investment is Rs.2,95,170/-. Thus a sum of Rs.3,50,976/- was therefore available with him to meet out the household expenditure of his family consisting of only one member in financial year 2011-12.
- (4) In the statement of movable and immovable property for the financial year 2012-13, Sri Singh's total Income from Salary is Rs.6,35,500/- from this amount, he has paid Rs.50,084/- against CPF, Rs.2400/- against GIS, Rs.31,710/- against Income Tax, Rs.74,260/- against LIC. As such, total deductions /Savings/investment is Rs.1,58,454/- . The balance of his Saving Bank Account(s) decreased for Rs.29,337/- this financial year. Thus a sum of Rs.5,06,383/- was therefore available with him to meet out the household expenditure of his family consisting of two members in financial year 2012-13.
- (5) In the statement of movable and immovable property for the financial year

2013-14, Sri Singh's Total Income from Salary is Rs.7,88,436/- from this amount, he has paid Rs.54,309/- against CPF, Rs.2400/- against GIS, Rs.49,996/- against Income Tax. As such, total deductions /Savings/investment is Rs.1,06,705/-. The balance of his Saving Bank Account(s) decreased for Rs.1,38,535/- this financial year. Thus a sum of Rs.8,20,266/- was therefore available with him to meet out the household expenditure of his family consisting of two members in financial year 2013-14.

(6) In the statement of movable and immovable property for the financial year 2014-15, Sri Singh's total Income from Salary is Rs.8,04,689/- from this amount, he has paid Rs.75,612/- against CPF, Rs.2400/- against GIS, Rs.49,780/- against Income Tax, Rs.5,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.1,53,749/- this financial year As such, total deductions /Savings/investment is Rs.2,43,922/- . Thus a sum of Rs.5,60,767/- was therefore available with him to meet out the household expenditure of his family consisting of two members in financial year 2012-13.

The movable and immovable property statement for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 has been submitted by the officer ^{firstly} vide his letter dated 20.7.2015 (flag 'B'). The Property Statements for the financial years 2009-10 and 2010-11 was due to be submitted in the financial year 2011-12 i.e. on or before 31.3.12, Property Statements for the financial years 2011-12 and 2012-13 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14 and Property Statements for the financial years 2013-14 and 2014-15 was due to be submitted in the financial year 2015-16 i.e. on or before 31.3.16 As such there is delay in submitting the Property statements for the financial years 2009-10, 2010-11, 2011-12, 2012-13 from the part of the officer.

In this connection, it is submitted that Sri Singh has already submitted his property statement of at the time of entering into Judicial Service which was seen by Hon'ble Mr. Justice S.S.Chauhan, the then Administrative Judge, Shahjahanpur on 21.1.2014 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 of Sri Kuldeep Singh-III, Additional Civil Judge(Jr.Div.), Shahjahanpur may kindly be laid before Hon'ble Mr. Justice Harsh Kumar, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal and orders ?
