May kindly see the letters, placed below at flag 'A', received from Sri Sushil Kumar-V, Metropolitan Magistrate, Kanpur Nagar regarding issuance of 'No Objection Certificate'/'Identity Certificate' for obtaining Passport.

In his letter, Sri Sushil Kumar has stated that he would like to go abroad/foreign in future for education, tour medical purposes and for the same passport is required to him. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Smt. Jyoti (Wife), Km. Shravistha Kanaujia (Daughter) & Master Sarthvik Kanaujia (Son). He has, therefore, requested for issuance of 'No Objection Certificate'/'Identity Certificate' for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Sushil Kumar. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Tarun Agarwala, Administrative Judge, Kanpur Nagar Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Sushil Kumar-V, Metropolitan Magistrate, Kanpur Nagar as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
