May kindly see the letter dated 26.11.2014 (flag A) placed below received from Sri Sushil Kumar-V, Mahanagar Magistrate, Kanpur-Nagar has submitted his revised movable and immovable property statement for the financial years 2009-10 (i.e. From 6.1.2010 to 31.3.10), 2010-11, 2012-13 and 2013-14 to the Court.

Earlier he has submitted his property statement for the financial years 2009-10, 2010-11 and 2011-12 vide his letter dated 29.6.12 (flag 'B') but he has submitted property statement for the period 6.1.10 to 31.3.10, then a Court's letter dated 21.8.12(flag 'C') has been sent to the officer to sent his property statement for the period 6.1.10 to 31.3.10 after mentioning details of gross income, saving and PPF A/c, saving A/c in bank and post office etc. In reply of aforesaid Court's letter, officer has submitted his property statement for the period 6.1.10 to 31.3.10 and financial years 2010-11, 2011-12 without mentioning the detail of deductions vide his letter dated 66.3.14(flag 'D'). Again a Court's letter dated 31.3.14(flag 'E') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted his revised movable property statements property statement for the period 6.1.10 to 31.3.10 and financial years 2010-11, 2011-12, 2012-13 and 2013-14 after mentioning his details of deductions etc. vide his letter dated 26.11.14 (flag 'A').
