May kindly see the letters, placed below at flags 'A' & 'A-1', received from Sri Sushil Kumar, Additional Civil Judge (Junior Division), Faizabad by which he has requested for grant of permission to get firearm's licence and to purchase a firearm.

In his letters, Sri Sushil Kumar has stated that due to some safety reasons, he wants to purchase firearm for which he is in need of firearm's licence. He has applied for grant of permission to purchase the firearm to the Hon'ble Court according to this Court's C.L. no. 11/IVh-16/ Admin (A) dated 12.04.2010. He has, therefore, requested keeping in view the safety reasons of the officer for grant of permission to purchase the firearm as well as to get firearm's licence. He has also stated that he is willing to purchase a Revolver from Small Arms Factory, Kanpur which costs approx. Rs. 90,000/-. After obtaining permission from the Hon'ble Court and getting firearm's licence from the Licensing Authority, the purchase price of the Revolver will be paid from amount of his savings bank account no. 31027883053, SBI, Faizabad through cheque or D.D. and having paid the total amount of the Revolver, he would immediately submit full details and relevant papers of the purchase transaction.

Therefore, the officer has submitted that as his paternal residence is quite far from the main city and as his family's prosperity and his own position is quite good, social jealousy is a natural thing for which due to safety reasons, ~~thus~~, he is in need of firearm for which the permission of the Hon'ble Court is essential.

Under the facts and circumstances, if approved, the file may be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and if His Lordship approves, Sri Sushil Kumar, Additional Civil Judge (Junior Division), Faizabad may be accorded permission to purchase a Revolver from Small Arms Factory, Kanpur, as requested, subject to the condition that he will submit full pointwise details and papers of the purchase after completion of the purchase transaction immediately, under C.L. no. 25/ Admin (A) dated 13.07.1998?
