May kindly see the letters dated 30.7.2016 (flagged 'A', 'A-1' and 'A-2') ) by which Smt. Babita Rani, Additional District Judge, Saharanpur has submitted her Movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 in reply of Court's letter dated 15.6.16(flag 'B').

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given.

(i) In the financial year **2010-11**, Smt. Babita Rani's *Gross Income* is Rs.1,96,314 (for two months as per her date of joining) from this amount Rs.240/- deducted against GIS, Rs.16,400/- towards car loan, Rs.6480/- against LIC (Premium) and the balance of her Saving Bank Account(s) enhanced for Rs.21,648/- this year. As such, total deductions/repayment/Savings/investment is Rs.44,528/-. Thus a sum of Rs.1,51,786/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2010-11.

(ii) In the financial year **2011-12**, Smt. Babita Rani's *Gross Salary* is Rs.11,16,284/- from this amount Rs.4800/- deducted against GIS, Rs.98,400/- towards car loan, Rs.6480/- against LIC (Premium), Rs.1,00,000/- against PPF, Rs.1,11,889/- against *Income Tax*, Rs.10,180/- against Bajaj Health policy and the balance of her Saving Bank Account(s) enhanced for Rs.3,29,285/- this year. As such, total deductions/repayment/Savings/investment is Rs.6,61,034/-. Thus a sum of Rs.4,55,250/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2011-12.

(iii) In the financial year **2012-13**, Smt. Babita Rani's *Gross Salary* Rs.11,51,447/- from this amount Rs.4800/- deducted against GIS, Rs.184,242/- against CPF, Rs.98,400/- towards car loan, Rs.84,564/- against LIC (Premium), Rs.1,00,000/- against PPF, Rs.1,23,355/- against *Income Tax*, Rs.10,370/- against Bajaj Health policy. As such, total deductions/repayment/Savings/investment is Rs.6,05,731/- and the balance of her Saving Bank Account(s) decreased for Rs.80,369/- this year. Thus a sum of Rs.6,26,085/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2012-13.

(iv) In the financial year **2013-14**, Smt. Babita Rani's Gross Salary Rs.13,36,306/- from this amount Rs.48,000/- deducted against GIS, Rs.1,59,128/- against CPF, Rs.98,400/- towards car loan, Rs.84,564/- against LIC (Premium), Rs.1,00,000/- against PPF, Rs.1,79,484/- against Income Tax, Rs.10,370/- against Bajaj Health policy. The balance of her Saving Bank Account(s) enhanced for Rs.4,20,241/- this year. As such, total deductions/repayment/Savings/investment is Rs.10,56,987/-. Thus a sum of Rs.2,79,319/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2013-14.

(v) In the financial year **2014-15**, Smt. Babita Rani's Income from Salary and other Sources is Rs.19,44,064/- (Rs.16,86,903/- from Gross Salary Rs.2,57,161/- from arrears of LL.M.) from this amount Rs.1,59,415/- deducted against CPF, Rs.44,000/- against GIS, Rs.84,564/- against LIC (Premium), Rs.1,50,000/- against PPF, Rs.2,69,372/- against Income Tax and Rs.15,000/- against NSC. The balance of her Saving Bank Account(s) enhanced for Rs.2,96,992/- this year. As such, total deductions/repayment/Savings/investment is Rs.9,79,743/-. Thus a sum of Rs.9,64,321/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2014-15.

(vi) In the financial year **2015-16**, Smt. Babita Rani's Gross Salary is Rs.16,86,117/- from this amount Rs.1,68,351/- deducted against CPF, Rs.52,000/- against GIS, Rs.84,564/- against LIC (Premium), Rs.1,50,000/- against PPF, Rs.2,80,848/- against Income Tax. The balance of her Saving Bank Account(s) enhanced for Rs.1,72,229/- this year. As such, total deductions/repayment/Savings/investment is Rs.8,61,192/-. Thus a sum of Rs.8,78,725/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2015-16.

It is pertinent to mention here that the husband of the officer Sri Manoj Kumar Tyagi is an Advocate whose Annual income Rs.2,00,000/- (in the financial year 2010-11), Rs.2,25,000/- (in the financial year 2011-12), Rs.3,07,050/- (in the financial year 2012-13), Rs.3,27,000/- (in the financial year 2013-14), Rs.4,25,000/- (in the financial year 2014-15) and Rs.4,50,000/- (in the financial year 2015-16).

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 has —

been submitted by the officer vide her letter dated 30.7.16 (flagged 'A' 'A-1' & 'A-2')  
The property statements for the financial 2010-11 and 2011-12 was due to be submitted in third financial years 2012-13 i.e on or before 31.3.13, property statements for the financial 2012-13 and 2013-14 was due to be submitted in third financial years 2014-15 i.e on or before 31.3.15 and property statements for the financial 2014-15 and 2015-16 was due to be submitted in third financial years 2016-17 i.e on or before 31.3.17. As such there is delay in submitting the Property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14, from the part of officer for which officer has stated that due her transfer, she was unable to submit the aforesaid statements in due time for which she has regretted and assured that the same will not be repeated in future.

In this connection it is submitted last time Smt. Babita Rani had already submitted her property statement of at the time of entering into Higher Judicial Service which had already been seen by Hon'ble Mr. Justice Imtiyaz Murtaza, the then Administrative Judge, Ramabai Nagar Judgeship on 17.7.12, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 and 2015-16 of Smt. Babita Rani, Additional District Judge, Saharanpur may kindly be laid before Hon'ble Mr. Justice R.D.Khare, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
