May kindly see the letter dated 24.3.2017 at flag 'A' of Sri Anmol Pal, Additional District and Sessions Judge, Agra by which he has submitted his Property statements for at the time of entering into Higher Judicial Service and for the financial years 2011-12, 2012-13, 2013-14 and 2014-15...

Earlier Sri Pal has submitted his only movable property statements of at the time of entering into Higher Judicial Service and for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 vide his letter dated 5.8.16 (flag 'A) but neither he has submitted his immovable property statements nor details of deductions of his Salary for the aforesaid periods, hence a Court's leter dated 4.11.22016(flag 'B') has been sent to the officer int-his regard.

In reply of the aforesaid Court's letter, Officer vide his letter dated 24.3.2016 (flag 'A') has submitted his revised property statements for aforesaid periods.

In this connection, it is submitted that as per statement of movable and immovable property of at the time of entering into Higher Judicial Service and for the financial years 2012-13, 2013-14, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1)At the time of entering into Higher Judicial Service, Officer has I-10 Carprice Rs. 5,16,000/- Date of purchase 14.2.2009, Ornament of gold about 220 gms & Silver about 400 gms. Provided at the time of marriage to his wife by her parents and Iter on by his parents, one S.B. A/c no...7076 in HDFC Bank balance on 11.3.2011 Rs.27,270/-, F.D. no....3969 HDFC Bank initial amount fixed Rs. 2,25,000/- on 16.9.2008.

- (2) In the consolidated statement of movable and immovable property for the financial years 2011-12 and 201213, Sri Pal's Gross income from Salary is Rs.20,28,318/- from this amount, he has paid Rs.8,640/- against GIS, against Income Tax and Rs.24,000/- against Max life Rs.2,93,361/-The balance of his Saving Bank Accounts(s) enhanced for Rs.5,39,341/- in this financial year against the balance of previous year. . As such, total deductions/Saving/ investment is Rs.8,65,362/-. Thus a sum of Rs.11,62,956/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2011-12 and 2012-13.
- (3) In the consolidated statement of movable and immovable property for the financial years 2013-14 and 2014-15, Sri Pal's Gross income from Salary is Rs.28,22,375/- from this amount, he has paid Rs.9600/- against GIS, Rs.2,02,859/- against CPF, Rs.3,96,167/- against Income Tax and Rs.24,000/against Max life Insurance. As such, total deductions/Saving/ investment is Rs.6,32,626/-/-. The balance of his Saving Bank Accounts(s) decreased for Rs.96,005/- in this financial year against the balance of previous year. Thus a sum of Rs.22,85,754/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the

financial years 2013-14 and 2014-15 .

The movable and immovable property statement of at the time of entering into Higher Judicial Service and financial years 2011-12, 2012-13, 2013-14, 2014-15 has been firstly submitted by the officer vide his letters dated 5.8.16 (flag 'B'), property statement of at the time of entering into Higher Judicial service was due to be submitted at the time of joining the Higher Judicial Service, Property statements for the financial years 2011-12 and 2012-13 'was to be submitted in the financial year 2013-14 and Property statements for the financial years 2013-14 and 2014-15 was to be submitted in the financial year 2015-16. there is delay in submitting the Property statement of at the time of entering into the Higher Judicial Service and financial years 2011-12, 2012-13, 2013-14, 2014-15 from the part of officer for which officer has stated that he was earlier Addl. Civil Judge(Jr.Div.), Mirzapur from July 2009 to January 2011. He had submitted his property statement in Dec. 2010. Afterwards his resignation was accepted on Jan. 31, 2011 and he joined the Higher Judicial service on March 11, 2011. Since he had submitted property statement in Dec. 2010 before the Hon'ble High Court of Judicature at Allahabad. He bonafidely mistook that the same would be applicable for the present service too. As regards non submission of property statement of later years, he had forgotten to send the same because of work load. However, he wis submitted in future property statements would be sent in time. He, therefore, request that the Hon'ble Court may kindly be pleased to condone the delay in filling property statement in the above facts and circumstances. He will remain grateful.
