With reference to yourendorsement no. 2779/XV dated 27.07.2018, on the above subject, I have to say that from perusal of the statement about movable and immôvable property of Sri Inder Preet Singh Josh; Principal Judge, Family Court, Gautam Budh Nagar for the financial years 2011-12 to 2014-15, some information have not been found, so he may kindly be asked to furnish the following details/ information to the Court at an early date, so that further necessary action may be taken in the matter:

- 1. It is not clear how he managed his family in the financial year 2012-13 & 2014-15 with such a meagre amount. To clarify the actual position about the point raised with supporting papers:
  - (a). In movable property statement for the financial Year 2012-13, he has mentioned his income from salary is Rs.12,05,051/- and interest of FD & SB a/c is Rs.30,000/-. Thus the total income is Rs.12,35,051/- and from this amount, Rs.4,800/- deducted against GIS, Rs.25,126/- deposited in premium of LIC policies, Rs.1,00,000/- against PPF, Rs.15,000/- against Medical policy, Rs.1,31,146/- deducted as Income Tax, Rs.50,000/-/- against FDR, Rs.55,236/- against PLI and Rs.7,96,176/- deposited/enhanced in SB accounts, As such, his total deductions/ savings is Rs.11,77,484/-. Therefore, a sum of Rs.57,567/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year.
  - (b). In movable property statement for the financial year 2014-15, he has mentioned his income from salary is Rs.16,96,994/- and interest of FD & SB a/c is Rs.1,77,198/-. Thus the total income is Rs.18,74,192/- and from this amount, Rs.3,680/- deducted against GIS, Rs.25,126/- deposited in premium of LIC policies, Rs.1,50,000/- against PPF, Rs.15,000/- against Medical policy, Rs.3,47,517/- deducted as Income Tax, Rs.11,00,000/-/- against FDR, Rs.2,81,432/- against NPS and Rs.55,236/- against PLI. As such, his total deductions/ savings is Rs.19,77,991/- and Rs.1,08,735/- reduced in his SB accounts from previous year. Therefore, a sum of Rs.4,936/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.
- 2. To furnish the amount deducted against NPS in the financial year 2013-14 & 2014-15 (excluding Govt. contribution & profit).
- 3. To furnish the FDRs (with amount) purchased and <u>maturity amount</u> of FDR received in each financial year (2011-12 to 2016-17).
- 4. To submit the reasons for late submission of property statements of the financial years 2013-14 & 2014-15 and 2015-16 & 2016-17 (as the officer has submitted on 10.08.2016
