May kindly see the letter at flag 'Z' & 'Z-1', received from Sri Sanjiv Pandey, Additional District & Sessions Judge, Saharanpur regarding grant of permission to visit Macau and Hong Kong.

In his letter dated 20.03.2013 (flag 'Z'), Sri Pandey has stated that during the period between 08.06.2013 and 18.06.2013, he wishes to visit Macau and Hong Kong with his family. Due to his visit, there is no possibility of arising any embarrassing position before the Union Government or Govt. of U.P. He has not visited any foreign country after joining the judicial service and his foreign visit is totally for touring purpose and its expenditure will be borne out by his and his domestic savings. He has, therefore, requested that the Hon'ble Court may kindly be moved to grant him permission to visit abroad.

On asking some other details/ declarations as per relevant G.O., vide Court'e letter dated 17.04.2013 (flag 'B'), Sri Pandey has also submitted through his letter dated 30.04.2013 at flag 'Z-1', that:-

- 1. No permission to go abroad was ever refused earlier.
- 2. He and his wife visited Mauritius from 08.03.2001 to 14.03.2001, prior to his joining the judicial service.
- 3. Estimated expenditure of the above said abroad visit shall be approximately Rs. 2,50,000/- (Copy of the estimated cost of the package attached is at flag 'A-1'). Copy of his as well as his wife's statement of account indicating the source of fund for the above said visit are at flags 'A-2'). Total amount in his account is Rs. 2,67,319/- and in his wife's account is Rs. 4,39,102/-.
- 4. Copy of passport of his and his family members are submitted (flag 'A-3').

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). As per reports, placed below, no vigilance / departmental enquiry is pending against Sri Sanjiv Pandey. His request may be considered favourably as the officer has submitted required details and papers. Here, it is also to mention that wife of the officer is also employed and working as Managing Diector, APPREF, Mohali, getting salary of about Rs. 1,00,000/- per month, as mentioned in officer's property statement, submitted at the time of joining the judicial service on 10.01.2011 (flag 'D').

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice Prakash Krishna, Administrative Judge, Saharanpur for His Lordship's kind perusal and if His Lordship approves, Sri Sanjiv Pandey, Additional District & Sessions Judge, Saharanpur may be granted permission to visit Macau and Hong Kong along with his family, in the month of

June 2013 i.e. during the period in between 08.06.2013 and 18.06.2013 as requested, subject to the conditions that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?
