May kindly see the letter at flag 'A', received from Sri Sanjiv Pandey, Additional District & Sessions Judge, Saharanpur regarding grant of permission to visit London (U.K.) between 08.08.2013 and 25.08.2013.

In his letter dated flag 'A', Sri Pandey has stated that he wants to go London (U.K.) between 08.08.2013 and 25.08.2013 in connection with marriage of daughter of his near family friend. Due to his visit, there is no possibility of arising any embarrassing position before the Union Government or Govt. of U.P. All the expenses of his visit will be borne from his personal and family savings. He has also submitted that:-

1. No permission to go abroad was ever refused earlier.
2. He and his wife visited Mauritius from 08.03.2001 to 14.03.2001, prior to his joining the judicial service. He also visited Macau and Hong Kong from 11.06.2013 to 17.06.2013 after obtaining due permission of the Hon'ble Court, communicated to him through Court's letter no.7261/ IV- 3937/ Admin (A) dated 22.05.2013.
3. Return journey fare of London costs for Rs. 50,000/-. There will be no expenditure on fooding and lodging as he is going in marriage. Apart from this, there may be some misc. expenses of Rs. 50,000/-, which he will manage from his savings account having sufficient balance (Copy of statement of account is at flag 'B').
4. Copy of his passport is submitted (flag 'B-1').
5. Copy of 'Invitation Card' of the marriage is submitted (flag 'B-2').

He has, therefore, requested for grant of permission to visit London for the purpose.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). As per reports, placed below, no vigilance / departmental enquiry is pending against Sri Sanjiv Pandey. However, the officer has submitted required details and papers of his proposed visit, acceptance of his request is on the discretion of Hon'ble Court, as the officer has recently visited Macau and Hong Kong in the month of June 2013 for tourism purpose, for which permission was granted vide Court's order dated 21.05.2013 (flag 'XX'), communicated vide Court's order no. 7260/ IV- 3937/ Admin (A) dated 22.05.2013.

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice Prakash Krishna, Administrative Judge, Saharanpur for His Lordship's kind perusal and if His Lordship approves, Sri Sanjiv Pandey, Additional District & Sessions Judge, Saharanpur may be granted

permission to visit London (U.K.) between 08.08.2013 and 25.08.2013, to attend marriage of daughter of his near family friend, as requested, subject to the conditions that proper charge of Government records or cash, if any, or any government property with him, may be handed over by him before proceeding abroad?
