In his letters, Sri Pandey has stated that he wants to pursue Master of Laws (LL.M), as Correspondence Course from Kurukshetra University, Kurukshetra for which he has applied in the Session 2011-12. From doing the Course through correspondence, there will be no adverse effect on his duties.
