In his letters, Sri Pandey has stated that he wants to pursue Master of Laws (LL.M), as Correspondence Course from Kurukshetra University, Kurukshetra for which he has applied in the Session 2011-12 . From doing the Course through correspondence, there will be no adverse effect on his duties. He has, therefore, requested for grant of permission to pursue LL.M. through Correspondence Course from Kurukshetra University, Kurukshetra(Haryana).

In the instant case, it is to mention that the officer has joined the U.P.Higher Judicial Service on 10.1.11. He wants to pursue LL.M. Correspondence Course from Kurukshetra University, Kurukshetra. Acceptance of his request to pursue the course of LL.M. from Kurukshetra University, Kurukshetra through correspondence may be considered as there appears to be no necessity to join any classes, but it is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No.24/1066-Appointment (B) dated 21.08.1967(copy at flag X), subject to the following conditions:-

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

Under the circumstances, if approved by Hon'ble the Chief Justice, Sri Sanjeev Pandey, Additional District and Sessions Judge, Saharanpur may be accorded permission to pursue the course of LL.M. from Kurukshetra University, Kurukshetra through Correspondence from the academic Sessions 2011-12 subject to the conditions mentioned above?
