May Kindly peruse the office note dated 29.8.2011. 2. Maruti 800 Car for Rs. 1,80,665/- in 1999.
3. Revolver for Rs. 59,879/- in 2003.
4. Plot No. 3/228, Viraj Khand, Gomti Nagar, Lucknow for Rs. 5,21,015/- in 2003.

Note: Scooter is stated to be purchased from scooter advance sanctioned by D.J. Gonda. However, there appears to be no information about purchase of the same.
