

**Deputy Registrar(M)**

May kindly see the letter dated 3.6.14 (flagged 'A' ) by which Sri Sanjiv Pandey, Registrar, Central Administrative Tribunal, Chandigarh Bench, Chandigarh ( an officer of U.P.H.J.S., who is presently posted on deputation there) has submitted his revised Movable and immovable property statement for the financial years 2010-11 and 2011-12.

Earlier Sri Pandey had submitted his movable and immovable property statement for the financial years 2010-11 (i.e. for the period from 10.1.11 to 31.3.11), 2011-12 and 2012-13 vide his letters dated 31.3.14 (flag 'B', 'B-1' and 'B-2') but some informations i.e. his total gross salary, details of deductions, amount deposited in the PPF A/c, Saving Bank A/cs., annual premium of Insurances, Installment of House loan were not mentioned, hence a Court's letter dated 13.5.2014(flag 'C') has been sent to the officer in this regard to the officer.

In reply of aforesaid Court's letter, Officer has submitted his revised property statements for the financial years 2010-11 (i.e. for the period from 10.1.11 to 31.3.11) and 2011-12 vide his letter dated 3.6.14(flag 'A'). The property statement for the financial year 2012-13 will be dealt alongwith Property statement for the financial year 2013-14, when officer will send his property statement for the financial year 2013-14.

In this connection, it is submitted that the date of joining of the officer is 10.1.2011. As per statement of movable and immovable property for the financial years 2010-11 (i.e. for the period from 10.1.11 to 31.3.11) <sup>& 2011-12</sup> of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- (1) In the financial year 2010-11(i.e. for the period from 10.1.11 to 31.3.11) Gross Income from salary of Sri Pandey is Rs.1,33,476/- and from this amount, <sup>& deductions are</sup> Rs.54,193/- against Income Tax, Rs.800/- against GIS, and Rs.2448/- towards House loan. The balance of his Saving Bank Account(s) enhanced for Rs.8165/- this year. As such, total deductions /Savings /investment is Rs.65,606/-. Thus a sum of Rs.67,870/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2010-11. However, he has income from advocacy before his joining and in that particular year, he has an income of Rs.7,28,000/- from earlier profession before his joining.
- (2) In the financial year 2011-12 Gross Income from salary and other Sources of Sri Pandey is Rs.11,49,173/- and from this amount, Rs.89,740/- against CPF, Rs.1,00,000/- deducted against PPF, Rs.1,17,307/- against Income Tax, Rs.4800/- against GIS, Rs.32,712/- against LIC. As such, total deductions /Savings /investment is Rs.3,44,559/-. The balance of his Saving Bank Account(s) decreased

for Rs.67,254/- this year. Thus a sum of Rs.8,71,868/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2011-12.

*It is pertinent to mention here that the wife of officer Smt. Vibha Pandey is working as Managing Director APPERF, in Mohali whose Gross Income was Rs.15,98,751/- (in the financial year 2010-11) and Rs.19,23,530/- (in the financial year 2011-12).*

The movable and immovable property statement for the financial years 2010-11 and 2011-12 has been submitted by the officer firstly vide his letter dated 31.3.14 (flagged 'B' and 'B-1') which was due to be submitted in third financial years 2012-13, i.e on or before 31.3.13 . As such there is delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted Sri Pandey had already submitted his property statement of at the time of entering into Judicial Service which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Saharanpur which is at flag 'Z', and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11 (i.e. for the period from 10.1.11 to 31.3.11) and 2011-12 of Sri Sanjiv Pandey, Registrar, Central Administrative Tribunal, Chandigarh Bench, Chandigarh (an officer of U.P.H.J.S., who is presently posted on deputation there) may kindly be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders ?
