May kindly see the letters dated 17.3.15 (flagged 'A' and 'A-1') by which Sri Sanjiv Pandey, Registrar, Central Administrative Tribunal, Chandigarh Bench, Chandigarh (an officer of U.P.H.J.S.), who is presently posted on deputation there) has submitted his ~~movable~~ Movable and immovable property statement for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- (1) In the financial year 2012-13, Income from salary of Sri Pandey's is Rs.11,64,995/- and from this amount, Rs.1,00,000/- against PPF, Rs.4800/- against GIS, Rs.1,23,883/- against CPF, Rs.32,712/- against LIC, Rs.1,31,210/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.1,86,982/- this year. As such, total deductions /Savings /investment is Rs.5,79,587/-. He has also received Rs.92,797/- as interest from his Saving Bank Accounts. Thus a sum of Rs.6,78,205/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.
- (2) In the financial year 2013-14, Income from salary of Sri Pandey's is Rs.13,44,240/- and from this amount, Rs.1,00,000/- against PPF, Rs.4800/- against GIS, Rs.1,24,204/- against CPF, Rs.32,712/- against LIC, Rs.1,71,240/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.39,890/- this year. As such, total deductions /Savings /investment is Rs.4,72,846/-. He has also received Rs.1,10,872/- as interest from his Saving Bank Accounts. Thus a sum of Rs.9,82,248/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.

It is pertinent to mention here that the wife of officer Smt. Vibha Pandey is working as Managing Director APPERF, in Mohali whose Salary was Rs.1,20,240/- per month (in the financial year 2012-13) and Rs.1,00,000/- per month (in the financial year 2013-14).

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letters dated 17.3.15 (flagged 'A' and 'A-1') which was due to be submitted in third financial years 2014-15 i.e on or before 31.3.15 . As such there is no delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted Sri Pandey had already submitted his property statement upto financial year 2011-12 which had already been seen by Hon'ble the Chief Justice on 4.12.14 which is at flag 'Z' and the said statement at flag 'M'.
