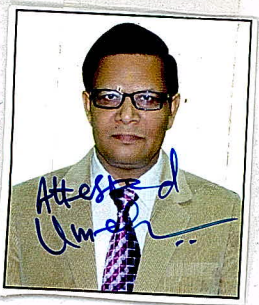

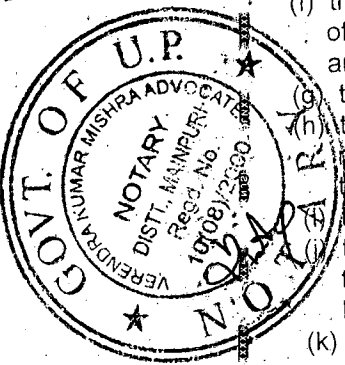

- (a) that the names of my dependent family members are as follows:

 - (iv) Son : Master Ekeshwar Bhardwaj
- (b) that the applicant is a citizen of India.
- (c) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India.
- (d) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India.
- (e) that the presence of the applicant from India may not, or is not likely to, prejudice the friendly relations of India with any foreign country.
- (f) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a Court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- (g) that proceedings in respect of any offence alleged to have not been committed by the applicant.
- (h) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
- (i) that the applicant has not been repatriated.
- (j) that there is not any possibility of arising embarrassing position before Government of U.P. due to my visit to any foreign country departure from India will not be detrimental to the security of India.
- (k) that the applicant has neither applied for 'Identity Certificate' for obtaining passport nor has been refused ever.
- (l) that the applicant has never visited any foreign country earlier.
