May kindly see the letter, placed below flag at 'X' & 'X-1' received from Sri Umesh Kumar Sharma, District & Sessions Judge, Mainpuri for issuance of 'No Objection/ Identity Certificate' for obtaining Passport.

In his letters, Sri Sharma has stated that he intends to visit abroad in near future for tourism purpose. Therefore he is in need of passport for himself and his spouse for which 'No Objection/ Identity Certificate' is required. He has also furnished passport size photographs of himself and required details and declarations on an 'Affidavit' as per G.O. and Section 6 (2) of Passport Rules, which may kindly be seen at flag 'Y'. His dependents are Smt. Suneeta Sharma (Wife), Km. Ankita Gaur and Km. Anamika Bhardwaj and Master Ekeshwar Bhardwaj (Son). He has, therefore, requested to place his application before Hon'ble Court for issuance of 'No Objection/ Identity Certificate' in his favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'Y-1'). Here it is also to submit that as per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Umesh Kumar Sharma. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mrs. Justice Vijay Lakshmi, Administrative Judge, Mainpuri and if Her Lordship approves, the 'Identity Certificate' at flag 'Z' be issued, in duplicate, in favour of Sri Umesh Kumar Sharma, District & Sessions Judge, Mainpuri as requested, for obtaining Passport with the direction of the Court that he should take prior permission of the Court before proceeding abroad?
