May kindly see the letter dated 19.11.2014 at flag 'A' of Sri Umesh Kumar Sharma, Additional District and Sessions Judge, Bulandshar^{W/O} has submitted his Statement of immovable property of at the time of joining into Higher Judicial Service and for the financial year 2012-13 and details of Saving Bank Accounts and FDR of his daughters.

Earlier Sri Sharma has submitted his property statements for the financial year 2011-12 vide his letter dated 30.3.12 (flag 'B') but he has not submitted his property statement of at the time of joining into Higher Judicial Service, hence a Court's letter dated 22.5.12 (flag 'C') then officer has submitted his property statement for the financial year 2013-14 vide his letter dated 21.4.2014(flag 'D'). Again a Court's letter dated 19.5.14 (flag 'E') has been sent to the officer to sent his property statement for at the time joining his Higher Judicial Service In reply of Court's letter officer has submitted his statements of at the time of entering into Judicial Service and financial years 2011-12, 2012-13 vide his letter dated 22.7.2014(flagged 'F') but he has not submitted his Statement of immovable property of at the time of entering into Judicial Service and for the financial year 2012-13 and details of Saving Bank Accounts and FDR of his Daughters. Thereafter a Court's letter dated 10.10.2014(flag 'G') was sent to the officer in this regard.

In reply of the aforesaid Court's letter, Officer has furnish his required statements and informations vide his letter dated 19.11.2014 (flagged 'A').

In this connection, it is submitted that as per statement of movable and immovable property of at the time of joining into Higher Judicial Service and for the financial years 2011-12 and 2012-13 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) at the time of entering into Judicial Service Sri Sharma's has two Saving Bank Accounts (i)SB A/c No...12040 Oriental Bank of Commerce, Ghaziabad balance Rs.1,14,222/- (ii)SB A/c No...00120 BAB, Modinagar balance Rs.15,005/- jointly with Smt. Suneeta Sharma , two LIC policies whose total annual premium is Rs.12,698/- and has Rs.2,46,375/- Income from Advocacy and Agriculture and One Desire Car Valued Rs.5,95,000/-, One air conditioner Value Rs.30,000/-, One Color T.V. Valued Rs.13,000/- Two Refrigerator Valued Rs.23,000/- One Computer Valued Rs.32,000/- One Washing Machine Valued Rs.7,500/- , two gold ring, One Gold chain, Silver coins/ 113, two silver rings with stones, Two Laptops Rs.74,000/- for one daughter and son, four Mobile phones etc.

(2) In the financial year 2011-12 Sri Sharma's total income from Salary and other Sources is Rs.1,93,373/- from this amount he has paid Rs.1200/- against GIS; Rs.12,630/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.1,56,437/- this year. As such, total deductions /Savings/investment is Rs.1,70,267/- Thus a sum of Rs.23,106/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2011-12.

It is pertinent to mention here that at the time of joining into Higher

Judicial Service i.e. as on 24.12.2011. Officer has Rs.2,46,375/- in hand from income from Advocacy and also his daughter Km. Akshika Gaur earns Rs.4,56,000/- as Asst. Manager in WIPRO, Delhi and Km. Ankita Gaur earns Rs.3,00,000/- per annum as Lecturer in KIET, Ghaziabad.

(3) In the financial year 2012-13, Sri Sharma's total income from Salary and other Sources is Rs.10,43,060/- from this amount he has paid Rs.4800/- against GIS, Rs.84760/- against CPF, Rs.1,26,803/- against Income Tax, Rs.12,630/- against LIC. As such, total deductions /Savings/investment is Rs.1,70,267/-. The balance of his Saving Bank Account(s) decreased for Rs.1,27,698/- this year. Thus a sum of Rs.9,41,765/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2012-13.

The movable and immovable property statement of at the time of Joining into Higher Judicial and for the financial years 2012-13 has been submitted by the officer vide his letter dated 22.7.14(flag 'F') and for the financial year 2011-12 vide his letter dated 30.3.12 (flag 'B') . The property statements for at the time of Joining in Higher Judicial Service was due to be submitted at the time of his Joining of Higher Judicial Service i.e. on 24.12.2011 and and for the financial years 2011-12 and 2012-13 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14 . As such there is delay in submitting the property statement for the financial year 2012-13 from the part of officer.

May, if approved, the statements of movable and immovable property of at the time of Joining into Higher Judicial and for the financial years 2011-12 and 2012-13 of Sri Umesh Kumar Sharma, Additional District and Sessions Judge, Bulandshahr may kindly be laid before Hon'ble Mr. Justice Rajiv Sharma, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders?
