May kindly see the letter dated 30.3.2016 and 21.7.17 (at flag 'A' and 'A-1') of Sri Umesh Kumar Sharma, District Judge, Mainpuri by which he has submitted his property statements for the financial years 2013-14 and 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and0 immovable property for the financial years 2013-14, Sri Sharma's Income from salary and other Sources is Rs.15,77,107/- (Rs.15,35,301/- from Gross Salary, Rs.30,000/- from Agriculture and Rs.11,806/- from interests) from this amount, he has paid Rs.4800/- against GIS, Rs.1,60,409/- against CPF, Rs.2,52,135/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.87,283/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.5,04,627/-. Thus a sum of Rs.10,72,480/- was therefore available with him to meet out the household expenditure of his family consisting of, five members in the financial year 2013-14.

(2) In the statement of movable and immovable property for the financial years 2014-15, Sri Sharma's Income from salary and other Sources is Rs.16,09,684/- (Rs.15,60,190/- from Gross Salary, Rs.30,000/- from Agriculture and Rs.19,494/- from interests) from this amount, he has paid Rs.4800/- against GIS, Rs.1,49,899/- against CPF, Rs.2,37,783/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.4,85,947/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.8,78,429/-. Thus a sum of Rs.7,31,255/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2014-15.

The movable and immovable property statement for the financial year 2013-14 and 2014-15 has been firstly submitted by the officer vide his letter dated 30.3.16 (flag 'A') which was due to be submitted in the financial year 2015-16 i.e. on before 31.3.16. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Sharma has already submitted his property statement upto financial year 2012-13 which was seen by Hon'ble Mr. Justice Rajiv Sharma, the then Administrative Judge, Bulandshahr Judgeship on dated 24.2.15 at flag 'Z' and the said statement is

at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2013-14 and 2014-15 of Sri Umesh Kumar Sharma, District Judge, Mainpuri may kindly be laid before Hon'ble Mrs. Justice Vijay Lakshmi, Administrative Judge, Mainpuri Judgeship for Her Lordship's kind perusal and orders ?
